Application of DONALD R. JOHNSON and JACK L. BISHOP, partners doing business as THE RIDGE TRUCKING COMPANY for authority to charge less than the minimum rates pursuant to Sections 3666 and 5195 of the Public Utilities Code.

OPINION AND ORDER

By this application, Donald R. Johnson and Jack L. Bishop, doing business as The Ridge Trucking Company, request authority to deviate from the provisions of Minimum Rate Tariff 2 in connection with the transportation of lumber for Brunswick Timber Products Corp. and Yuba River Lumber Co., Inc., from Crass Valley to Auburn.

The application is based on special circumstances and conditions detailed therein.

The application was listed on the Commission's Daily Calendar of January 4, 1977. California Trucking Association (CTA) opposed the exparte consideration of the application stating that there was not enough information to determine whether the proposed rate is related to the costs of performing the service and that costs presented are lump sum with no indication as to their source or accuracy. CTA declares that the application should be set for public hearing in conjunction with the anticipated public hearings covering the Commission's staff study of lumber and lumber products.

Revenue and expense data submitted by applicants are sufficient to determine that the transportation involved may reasonably be expected to be profitable under the proposed rate.

Applicant's proposal is not unlike other similar requests which have been granted and should not be delayed pending CTA's suggestion.

In the circumstances, the Commission finds that applicant's proposal is reasonable. A public hearing is not necessary. The Commission concludes that the application should be granted as set forth in the ensuing order and the effective date of this order should be the date hereof because there is an immediate need for this rate relief.

IT IS ORDERED that:

- l. Donald R. Johnson and Jack L. Bishop are authorized to perform the transportation shown in Appendix A attached hereto and by this reference made a part hereof at not less than the rate set forth therein.
- 2. The authority granted herein shall expire one year after the effective date of this order unless soconer cancelled, modified or extended by further order of the Commission.
