Application of Donel Products for authority to deviate from the minimum rates on scrap fiber products which may be in bales, boxes, or on pallets from Arcata to points in Richmond, Oakland, Antioch, Sacramento, and Red Bluff for the account of the Arcata Community Recycling Center.

OPINION AND ORDER

By this application, Donel Products requests authority to deviate from the provisions of Minimum Rate Tariff 2 in connection with the transportation of scrap or waste paper, in bales or in boxes on pallets, from Arcata to Antioch, Red Bluff, Richmond and Sacramento for Arcata Community Recycling Center.

By Decision 86074 dated July 7, 1976 in Application 56163 Donel Products was authorized to deviate from the minimum rates in connection with the transportation of scrap or waste paper in bales from Arcata to Oakland and Richmond for Arcata Community Recycling Center. This authority expired July 27, 1977.

The application is based on special circumstances and conditions detailed therein. Applicant by letter dated July 20, 1977 amended its request as to the charges per load to reflect the round-trip miles as provided in Distance Table 8.

Revenue and expense data submitted by applicant indicate that the transportation involved may reasonably be expected to be profitable under the proposed rates.

The application was listed on the Commission's Daily Calendar of June 30, 1977. No objection to the granting of the application has been received.

In the circumstances, the Commission finds that applicant's proposal is reasonable. A public hearing is not necessary. The Commission concludes that the application should be granted as set forth in the ensuing order and the effective date of this order should be the date hereof because there is an immediate need for this relief.

IT IS ORDERED that:

- l. Donel Products is authorized to perform the transportation shown in Appendix A attached hereto and by this reference made a part hereof at not less than the rates set forth therein.
- 2. The authority granted herein shall expire one year after the effective date of this order unless sooner cancelled, modified or extended by further order of the Commission.

The effective date of this order is the date hereof.

APPENDIX A

Donel Products is authorized to transport scrap or waste paper, in bales or in boxes on pallets, for Arcata Community Recycling Center from Arcata to Antioch, Red Bluff, Richmond and Sacramento at the following charges per unit of carrier's equipment:

Antioch	\$355.00
Red Bluff	234.00
Richmond	350.00
Sacramento	341.00

Conditions:

- 1. Shipments shall be power loaded by shipper and power unloaded by consignee without assistance of, or expense to, the carrier.
- 2. Applicant has not indicated subhaulers will be engaged nor have any costs of subhaulers been submitted. Therefore, if subhaulers are employed, they shall be paid not less than the charge authorized herein without any deduction for use of applicant's trailing equipment.
- 3. In all other respects, the rates and rules in Minimum Rate Tariff 2 shall apply.
