## ORDER OF REVOCATION

By Decision No. 86524 dated October 19, 1976 in Application No. 56656, as amended by Decision No. 87055 in Application No. 57019, Carmel Valley Transit Corporation was granted a Certificate of Public Convenience and Necessity to operate as a passenger stage corporation between Carmel Valley Village and Monterey Peninsula College and intermediate points.

Since April 27, 1977 Carmel Valley Transit Corporation has had no evidence on file with this Commission showing adequate protection against liability imposed by law for payment of damage for personal injury or property damage, as required by General Order No. 101-C.

On October 5, 1977 the Commission staff received a letter from Michael L. Newman, counsel for the carrier, that Carmel Valley Transit Corporation seeks to abandon the services as it has received poor public response. During the month of

January, 1977 the carrier transported only 132 passengers and received \$146.75 in fares. For the month of February 1977, 130 passengers were transported and \$133.00 in fares were received. The carrier alleged that its expenses exceeded \$600.00 per month and it has shown a net loss for the first three months of operations of \$2,286. He advised that it had published notice of abandonment of service on March 10, 1977.

It appears and the Commission finds that these matters constitute good cause for the revocation of the aforenamed certificate and that such revocation would not be adverse to the public interest. The Commission, therefore, concludes that the certificate should be revoked and that tariffs and timetables applicable to the service thereunder should be canceled.

IT IS ORDERED that the Certificate of Public Convenience and Necessity to operate as a passenger stage corporation authorized by Decisions 86524 and 87055 in Applications 56656 and 57019 respectively, is hereby revoked and all effective tariffs and timetables on file with the Commission in the name of Carmel Valley Transit Corporation are canceled upon the effective date of this order.
