OPINION AND ORDER

By this application, Pacific Southcoast Freight Bureau, Agent (PSFB) for and on behalf of the carriers participating in its Freight Tariff 244-F, seeks to increase all rates applicable to Scales 11 and 11A Cereal Food Preparations, described in Items 830 and 7455 in said tariff, by fifteen (15) percent at the Ex Parte 313 level, then add Ex Parte 330 and 336 increases to the result. The rates affected are published in Items 1040 to 4175 and 7500 to 32670 of PSFB Freight Tariff 244-F.

Applicant states that the California intrastate rates on cereal food preparations are and have been depressed, failing to return sufficient revenue to offset costs of performing the service required. Applicant avers that a general increase in said rates is the only solution to provide rail carriers an adequate return for equipment investment and service provided.

Applicant declares that the increase of fifteen (15) percent in cereal food preparations rates on interstate traffic, Scales 11 and 11A of Tariff 244-F, is published in Supplement 40 thereto.

Applicant asserts that increases resulting from the proposal would not increase the overall revenue of the carriers involved herein by more than one (1) percent. Applicant anticipates that the yearly revenue increase under the proposal should approximate not more than \$500.00.

Applicant alleges that the proposed rate increase was formally approved, under its Proposal 7864, by carrier members of its Freight Traffic Committee; that the proposal was publicized and distributed to all interested parties of record; and, there was no opposition to the approved fifteen (15) percent increase.

The application was listed on the Commission's Daily Calendar of September 19, 1977. No objection to the granting of the application has been received.

In the circumstances, the Commission finds that applicant's proposal is reasonable and justified to the extent indicated in the ensuing order. A public hearing is not necessary. The Commission concludes that the application should be granted.

IT IS ORDERED that:

1. Pacific Southcoast Freight Bureau, Agent, on behalf of the carriers which are parties to Pacific Southcoast Freight Bureau Tariff 244-F, is authorized to publish the tariff changes as specifically proposed in the application.

2. Tariff publications authorized to be made as a result of the order herein shall be filed not earlier than the effective date of this order and may be made effective not earlier than ten days after the effective date of this order on not less than ten days' notice to the Commission and to the public, and said authority shall expire unless exercised within ninety days after the effective date of this order.

3. The authority set forth herein is granted subject to the express condition that applicant and the carriers on whose behalf it is participating herein will never urge before the Commission in any proceeding under Section 734 of the Public Utilities Code, or in any other proceeding, that the opinion and order herein constitute a finding of fact of the reasonableness of any particular rate or charge. The filing of rates pursuant to the authority granted constitutes an acceptance by applicant and said carriers as a consent to the condition.

4. The authority herein granted shall expire unless exercised within ninety days after the effective date of this order.

The effective date of this order shall be twenty days after the date hereof.
