Application of EAGLE TRUCK LINES, INC., to sell, and RAMS EXPRESS to purchase, certain Certificates of Public Convenience and Necessity of EAGLE TRUCK LINES, INC. pursuant to Section 851 of the Public Utilities Code.

Eagle Truck Lines, Inc., a California corporation (seller), requests authority to sell and Rams Express, a California corporation, doing business as Pro Express (purchaser), requests authority to purchase and acquire certificates of public convenience and necessity authorizing operations as a highway common carrier. The certificates were granted by Decision 67838 dated September 15, 1964 in Application 44619 and Decision 76513 dated December 4, 1969 in Application 51504. These certificates authorize the transportation of general commodities with the usual exclusions (a) within the Los Angeles Basin Territory and between said Territory and San Diego and Escondido, and (b) over certain routes and also specific commodities over other routes in ah area between San Francisco and Sacramento Territories and the California-Mexican Border.

Pursuant to an agreement between the applicants dated May 5, 1977, filed as Exhibit 1 to the application, seller agrees to sell to the buyer the certificates hereinabove identified for a total purchase price of \$10,000 which is to be paid upon the date of consummation and closing.

Purchaser presently holds highway carrier permit authority issued by this Commission. Its financial statement of February 28, 1977 shows net worth of \$337,608.

Seller is a party to Western Motor Tariff Bureau, Inc., Agent, tariff publications to provide rates and rules for operations

under the certificates to be transferred. Purchaser proposes to adopt the tariffs.

A copy of the application has been forwarded to the California Trucking Association and notice of the filing appeared in the Commission's Daily Calendar of June 8, 1977. No protests to the application have been received.

After consideration, the Commission finds that the proposed sale and transfer of the operating rights would not be adverse to the public interest and concludes that the proposed transaction should be granted as set forth in the ensuing order. A public hearing is not necessary. The order which follows will provide for, in the event the transfer is completed, the revocation of the certificates presently held by Eagle Truck Lines, Inc. and the issuance of an in-lieu certificate in appendix form to Rams Express, a California corporation. The new certificate issued to Rams Express will not broaden in any way the scope of operating authority held by Eagle Truck Lines, Inc.

Purchaser is placed on notice that operative rights, as such, do not constitute a class of property which may be capitalized or used as an element of value in rate fixing for any amount of money in excess of that originally paid to the State as a consideration for the grant of such rights. Aside from their purely permissive aspect, such rights extend to the holder a full or partial monopoly of a class of business. This monopoly feature may be modified or cancelled at any time by the State which is not in any respect limited as to the number of rights which may be given. The authorization granted shall not be construed as a finding of value of the rights authorized to be transferred.

O R D E R

IT IS ORDERED that:

1. On or before April 30, 1978, Eagle Truck Lines, Inc., a California corporation, may sell and transfer the operative authority referred to in the application to Rams Express, a California corporation, doing business as Pro Express.

2. Within thirty days after the transfer the purchaser shall file with the Commission written acceptance of the certificate and a true copy of the bill of sale or other instrument of transfer.

3. Purchaser shall amend or reissue the tariffs on file with the Commission, naming rates and rules governing the common carrier operations transferred to show that it has adopted or established, as its own, the rates and rules. The tariff filings shall be made effective not earlier than ten days after the effective date of this order on not less than ten days' notice to the Commission and to the public, and the effective date of the tariff filings shall be concurrent with the transfer. The tariff filings made pursuant to this order shall comply in all respects with the regulations governing the construction and filing of tariffs set forth in the Commission's General Order 80-Series. Failure to comply with the provisions of General Order 80-Series may result in cancellation of the operating authority granted by this decision.

4. In the event the transfer authorized in Paragraph 1 is completed, effective concurrently with the effective date of the tariff filings required by Paragraph 3, a certificate of public convenience and necessity is granted to Rams Express, doing business as Pro Express, authorizing it to operate as a highway common carrier as defined in Section 213 of the Public Utilities Code between the points and over the routes set forth in Appendix A attached hereto and made a part hereof.

5. The certificates of public convenience and necessity granted by Decisions 67838 and 76513 are revoked effective concurrently with the effective date of the tariff filings required by Paragraph 3.

6. Purchaser shall comply with the safety rules administered by the California Highway Patrol and the insurance requirements of the Commission's General Order 100-Series.

7. To the extent any duplication of rights may exist, by reason of the transfer herein authorized, such operative rights may not be separated to permit Rams Express to sell or transfer one certificate authority and retain another certificate authority.

8. Purchaser shall maintain its accounting records on a calendar year basis in conformance with the applicable Uniform System of Accounts or Chart of accounts as prescribed or adopted by this Commission and shall file with the Commission, on or before April 30 of each year, an annual report of its operations in such form, content, and number of copies as the Commission, from time to time, shall prescribe.

9. Purchaser shall comply with the requirements of the Commission's General Order 84-Series for the transportation of collect on delivery shipments. If the purchaser elects not to transport collect on delivery shipments, it shall make the appropriate tariff filings as required by the General Order.

The effective date of this order shall be twenty days after the date hereof.

Rams Express, a California corporation, doing business as Pro Express, by the certificate of public convenience and necessity granted in the decision noted in the margin, is authorized to conduct operations as a highway common carrier as defined in Section 213 of the Public Utilities Code for the transportation of general commodities as follows:

I Between all points and places in Los Angeles Basin Territory as described in Note A hereof.

Between all points and places in San Francisco Territory as described in Note B hereof.

- II Between all points and places on and within ten (10) statute miles laterally of the following routes, including points within a ten (10) statute mile radius of such points.
 - Between Sacramento Territory as described in Note C hereof and Los Angeles Basin Territory as described in Note A hereof via State Highway 99 to its junction with Interstate Highway 5 near Wheeler Ridge, thence via Interstate Highway 5.
 - 2. Between San Francisco Territory as described in Note B hereof and Los Angeles Basin Territory as described in Note A hereof via U.S. Highway 101.
 - 3. Between El Rio in Ventura County and Los Angeles Basin Territory as described in Note A hereof via State Highway 1.
 - 4. Between San Fernando and Ventura via Interstate Highway 5 to its junction with State Highway 126 at Castaic Junction thence via State Highway 126.
 - 5. Between the junction of State Highway 14 and Interstate Highway 5 near San Fernando, and the junction of State Highway 126 and Interstate Highway 5 near Saugus, including unnumbered county roads via the cities of Newhall and Saugus.

In performing the service herein authorized, carrier may make use of any and all streets, roads, highways and bridges necessary or convenient for the performance of said service.

Lateral and Radial miles referred to in this appendix are statute miles of 5,280 feet each, measured in a straight line without regard to terrain features.

Carrier shall not transport any shipments having both origin and destination in the counties of Kern, Ventura or Santa Barbara.

Except that pursuant to the authority herein granted carrier shall not transport any shipments of:

 Used household goods, personal effects and office, store and institution furniture, fixtures and equipment not packed in salesmen's hand sample cases, suitcases,

overnight or boston bags, brief cases, hat boxes, valises, traveling bags, trunks, lift vans, barrels, boxes, cartons, crates, cases, baskets, pails, kits, tubs, drums, bags (jute, cotton, burlap or gunny) or bundles (completely wrapped in jute, cotton, burlap, gunny, fibreboard, or straw matting).

- Automobiles, trucks and buses, viz.: new and used, finished or unfinished passenger automobiles (including jeeps), ambulances, hearses and taxis, freight automobiles, automobile chassis, trucks, truck chassis, truck trailers, trucks and trailers combined, buses and bus chassis.
- 3. Livestock, viz.: barrows, boars, bulls, butcher hogs, calves, cattle, cows, dairy cattle, ewes, feeder pigs, gilts, goats, heifers, hogs, kids, lambs, oxen, pigs, rams (bucks), sheep, sheep camp outfits, sows, steers, stags, swine or wethers.
