ORDER OF REVOCATION

By Decision 85502, as amended by Decision 86282 in Application 56133, Donna L. Goodner and W. Anthony Sparks, doing business as Truckee Airport Transit Service, were granted a Certificate of Public Convenience and Necessity to operate as a passenger stage corporation between the Truckee-Tahoe Airport and the bus and rail depots in Truckee, on the one hand, and Squaw Valley, Alpine Meadows, Tahoe City, Tahoma, North Star, Kings Beach, Brockway, Prosser Lakeview Estates, Tahoe Donner Subdivision, Donner Lake, and certain intermediate points, on the other hand.

Since October 21, 1977, Truckee Airport Transit Service has had no evidence on file with this Commission showing adequate protection against liability imposed by law for payment of damage for personal injury or property damage, as required by General Order 101-C.

On November 18, 1977, the Commission staff sent letters by registered mail to W. Anthony Sparks and Donna L. Goodner, placing them on notice that the staff will recommend to the Commission that their authority be revoked unless they either file liability insurance or an explanation be given of their failure to commence operations by December 3, 1977. The Commission has not received any evidence on file for liability insurance or response from them.

It appears and the Commission finds that these matters constitute good cause for the revocation of the aforenamed certificate and that such revocation would not be adverse to the public interest. The Commission, therefore, concludes that the certificate should be revoked and that tariffs and timetables applicable to the service thereunder should be canceled.

IT IS ORDERED that the Certificate of Public Convenience and Necessity to operate as a passenger stage corporation authorized by Decision 85502, as amended by Decision 86282 in Application 56133, is hereby revoked and all effective tariffs and timetables on file with the Commission in the name of Donna L. Goodner and W. Anthony Sparks, dba Truckee Airport Transit Service, are canceled upon the effective date of this order.
