### OPINION AND ORDER

Westlam Foods, a California corporation, possesses prescriptive operative rights as a public utility warehouseman for the operation of storage or warehouse floor space at and in the vicinity of Chino, Durham and Sutter. By this application Westlam Foods requests authority to discontinue warehouse operations at Durham in Butte County.

Accordingly, the operative rights will be amended to show only Chino and Sutter. A public hearing is not necessary.


IT IS ORDERED that:

1. The prescriptive operative rights as a public utility warehouseman possessed by Westlam Foods, a corporation, as set forth in Appendix B of Decision 79971, in Application 46708, are amended by deleting Durham.

2. Appendix B of Decision 79971 is hereby superseded by Appendix A attached hereto.

3. Applicant shall, at the direction of the owner of any property in storage at the present location, transport such property to the facility of applicant at Sutter or any available public utility warehouse in the vicinity of present location at expense of applicant and at no expense or risk to the owner of the property transported.

4. Jack L. Dawson, Agent, is hereby authorized and directed to cancel the participation of Westlam Foods at Durham from the involved California Warehouse Tariff Bureau tariffs on file with the Commission, such cancellation to be made within ninety days after the effective date of this order on not less than ten days' notice to the Commission and to the public.

The Secretary is directed to cause service of a certified copy of this order to be made upon Westlam Foods or to mail a certified copy thereof to it at its last known address as shown in the Commission's records and to mail a copy of this order to Jack L. Dawson, Agent.

This order shall become effective twenty days after the date hereof.
