# FINAL OPINION

By Decision 86462 dated October 5, 1976, in this proceeding, the Commission authorized System 99, a California corporation, to acquire a portion of the highway common carrier operating authority of Associated Freight Lines,<sup>1</sup> a California corporation. This certificated authority was granted by this Commission pursuant to Decision 56845 dated June 17, 1959 in Application 39896. It was acquired by Associated Freight Lines through merger, pursuant to Decision 80404 dated August 29, 1972 in Application 50526. It authorizes operations as a highway common carrier of general commodities generally between the city of San Bernardino on the one hand, and Nipton and Goffs, located in eastern San Bernardino County, and all points within 35 statute miles of an unnumbered highway between Nipton and Goffs, on the other hand.

Decision 86462 also authorized System 99 to lease the said operating rights pending the issuance of an enabling order of the Interstate Commerce Commission under Section 5 of the Interstate Commerce Act. That decision also provided that this Commission would, by subsequent order, issue an "in lieu" certificate in appendix form to System 99 reflecting the consolidation of its prior and newly acquired certificates.

By amendment of its Articles of Incorporation, Associated Freight Lines changed its name to Best Way Freight Lines of Arizona. The restatement of the operating authorities herein neither broadens nor lessens the scope of the separate operating authorities heretofore granted. The effective date of this order should be the date on which it is signed since there is no reason to delay the disposition of this matter.

# <u>FINAL ORDER</u>

1. A certificate of public convenience and necessity is granted to System 99, a California corporation, authorizing it to operate as a highway common carrier, as defined in Section 213 of the Public Utilities Code, between the points and over the routes set forth in Appendix A of this decision.

2. In providing service pursuant to the authority granted by this order, System 99 shall comply with the following service regulations. Failure so to do may result in cancellation of the authority.

- (a) Within thirty days after the effective date of this order, System 99 shall file a written acceptance of the certificate granted. System 99 is placed on notice that if it accepts the certificate it will be required, among other things, to comply with the safety rules administered by the California Highway Patrol and the insurance requirements of the Commission's General Order No. 100-Series.
- (b) Within one hundred twenty days after the effective date of this order, System 99 shall establish the authorized service and amend or file tariffs, in triplicate, in the Commission's office.
- (c) The tariff filings shall be made effective not earlier than thirty days after the effective date of this order on not less than thirty days' notice to the Commission and the public, and the effective date of the tariff filings shall be concurrent with the establishment of the authorized service.

- (d) The tariff filings made pursuant to this order shall comply with the regulations governing the construction and filing of tariffs set forth in the Commission's General Order No. 80-Series.
- (e) System 99 shall maintain its accounting records on a calendar year basis in conformance with the applicable Uniform System of Accounts or Chart of Accounts as prescribed or adopted by this Commission and shall file with the Commission, on or before April 30 of each year, an annual report of its operations in such form, content, and number of copies as the Commission, from time to time, shall prescribe.
- (f) System 99 shall comply with the requirements of the Commission's General Order No. 84-Series for the transportation of collect on delivery shipments. If applicant elects not to transport collect on delivery shipments, it shall make the appropriate tariff filings as required by the General Order.

3. The certificate of public convenience and necessity granted in paragraph 1 of this order shall be in lieu of and supersede the highway common carrier certificates granted by Decision 56845 dated June 17, 1959 in Application 39896 and Decision 86102 dated July 13, 1976, in Application 54789, which certificates are revoked effective concurrently with the effective date of the tariff filings required by paragraph 2(b) hereof.

## SYSTEM 99 (a California corporation)

System 99, by the certificate of public convenience and necessity granted by the decision noted in the margin, is authorized to conduct operations as a highway common carrier as defined in Section 213 of the Public Utilities Code for the following transportation:

1. GENERAL COMMODITIES, with exceptions hereinafter noted, between all points and places located on the highways or in the defined areas or territories hereinafter enumerated, including points and places located within the specified lateral distances of such enumerated highways, areas or territories, or located within the specified radius of the cities named: (See Note 1)

- 1. All points located in or within 25 miles of the San Francisco Territory as described in Note A.
- 2. All points located in or within 25 miles of the Los Angeles Basin Territory as described in Note B.
- 3. All points in the San Diego Territory as described in Note C.
  - 4. All points located within a 25-mile radius of Blythe.
  - 5. All points located within a 25-mile radius of Sacramento.
  - 6. All points located within a 25-mile radius of Redding.
  - 7. Between San Ysidro and San Diego via Interstate Highway 5, including points located within 20 miles laterally thereof.
  - Between San Diego and San Francisco Territory via Interstate Highway 5 to its junction with U.S. Highway 101 (at Los Angeles), thence via U.S. Highway 101, including points located within 25 miles laterally of said route.

-9. Between San Francisco Territory and Ukiah via U.S. Highway 101, including points located within 25 miles laterally thereof.

10. Between San Francisco Territory and Ukiah, on the one hand, and points located on or within 10 miles laterally of that portion of U.S. Highway 101 lying between Scotia and Arcata, inclusive, on the other hand.

- 11. Between Scotia and Arcata via U.S. Highway 101, including points located within 10 miles laterally thereof, subject to Restrictions #1 and #2.
- 12. Between Arcata and Alturas via State Highway 299, including points within 20 miles laterally thereof, subject to Restrictions #1 and #2.
- 13. Between Alturas and the California-Oregon State Line via U.S. Highway 395.
- 14. Between Bartle and the junction of State Highway 299 with State Highway 89 (northeast of Burney) via State Highway 89, including points located within 10 miles laterally thereof.
- 15. Between Los Angeles and Sacramento via Interstate Highway 5 to its junction with State Highway 99 (near Wheeler Ridge), thence via State Highway 99, including points located within 25 miles laterally of said route.
- 16. Between Sacramento and Redding (a) via Interstate Highway 80, State Highway 65, State Highway 20, State Highway 99 and Interstate Highway 5 (east route); and (b) via Interstate Highway 80, State Highway 113 and Interstate Highway 5 (west route), including points located within 20 miles laterally of said routes.
- 17. Between San Francisco and Stockton via Interstate Highway 80, Interstate Highway 580, Interstate Highway 205 and Interstate Highway 5, including points located within 25 miles laterally of said route.

2. Automobiles, trucks and buses, viz.: new and used, finished or unfinished passenger automobiles (including jeeps), ambulances, hearses and taxis, freight automobiles, automobile chassis, trucks, truck chassis, truck trailers, trucks and trailers combined, buses and bus chassis.

- 8. Articles of extraordinary value.
- 9. Trailer coaches and campers, including integral parts and contents when the contents are within the trailer coach or camper.

Restriction #3: Carrier shall not transport commodities which have been sold at retail by a retail merchant, and transported from a retail store or retail store warehouse to residences of retail customers, or transported from residences of retail

west bank of the San Gabriel River; southerly along the west bank of the San Gabriel River to Beverly Boulevard; southeasterly on Beverly Boulevard to Painter Avenue in the City of Whittier; southerly on Painter Avenue to Telegraph Road; westerly on Telegraph Road to the west bank of the San Gabriel River; southerly along the west bank of the San Gabriel River to Imperial Highway (State Highway 90); westerly on Imperial Highway to Lakewood Boulevard (State Highway 19); southerly along Lakewood Boulevard to its intersection with State Highway 1 at Ximeno Street; southerly along Ximeno Street and its prolongation to the Pacific Ocean; westerly and northerly along the shoreline of the Pacific Ocean to a point directly south of the intersection of Sunset Boulevard and State Highway 1; thence northerly along an imaginary line to point of beginning.
