By D.88671 Charter-Party Carrier of Passengers
Permit No. TCP 325-P held by 24-Hour Airport Express, Inc.,
was continued in effect until July 14, 1978. By D.88687
Charter-Party Carrier of Passengers Permit No. TCP 951-P
held by Luxe Livery Service, Inc., also was continued in
effect until July 14, 1978.

By A.57765 (24-Hour Airport Express, Inc.) and by A.57850 (Luxe Livery Service, Inc.) the carriers seek to separate certain of their operations and to perform them as passenger stage corporations. Hearings on the two certificate applications were held on a consolidated record and the matters were submitted May 19, 1978 with the filing of concurrent briefs. We have today granted certificates of public convenience and necessity to conduct operations as a passenger stage corporation to applicants. However, certain operations of both applicants require charter-party authority. Both applicants' charter-party authority will expire on July 14, 1978 unless continued in effect by the Commission.

IT IS ORDERED that Charter-Party Carrier of Passengers Permit No. TCP 325-P held by 24-Hour Airport Express, Inc., and Charter-Party Carrier of Passengers Permit No. TCP 951-P held by Luxe Livery Service, Inc., are continued in effect until December 31, 1978.
