ORDER OF REVOCATION

By Decision 85783 dated May 4, 1976, in Application 56347, Hans Helge Hagerup Rasmussen, doing business as Santa Ynez Valley Bus Line, was granted a Certificate of Public Convenience and Necessity (PSC-996) to operate as a passenger stage Corporation between the communities of Buellton, Solvang, Santa Ynez and Santa Barbara and intermediate points.

At the request of the carrier, the authority was placed under suspension August 10, 1976 as it claims there was insufficient patronage to continue the service.

On April 3, 1978 the Transportation Division of the Commission sent a registered letter to the carrier stating that if it did not file adequate liability insurance and commence operations within fifteen days from the date of the letter or submit in writing a valid explanation as to why the authority is not being exercised, the staff will recommend to the Commission to revoke his authority. No reply has been received to the Commission staff's letter.

It appears and the Commission finds that these matters constitute good cause for the revocation of the forenamed certificate and that such revocation would not be adverse to the public interest. The Commission, therefore, concludes that the certificate should be revoked and that tariffs and timetables applicable to the service thereunder should be canceled.

IT IS ORDERED that the Certificate of Public Convenience and Necessity to operate as a passenger stage corporation authorized by Decision 85783 in Application 56347 is hereby revoked and all effective tariffs and timetables on file with the Commission in the name of Hans Helge Hagerup Rasmussen, doing business as Santa Ynez Valley Bus Line, are canceled upon the effective date of this order.
