<u>ORDER</u>

Daniel Michael Dunne and Martha Janet Dunne, dba Gold Country Treks (Treks), have applied for authority to operate as a passenger stage corporation for the transportation of passengers in Amador and Calaveras Counties. Proposed are three tours of the "Mother Lode" region: A tour from Jackson, a tour from Sutter Creek and a nightclub tour, including stops in Sutter Creek, Plymouth, Jackson and Mokelumne Hill. Proposed fares are \$12.00, \$9.00 and \$15.00, respectively. The transportation will be provided with a 12-passenger vanstyle bus.

Applicants allege that there is no bus service based in the Mother Lode "providing visitors and residents with small personally guided tours of the region's historic, cultural and natural attractions", and that a need exists for the proposed service.

A copy of the application was served on the Amador County Local Transportation Commission, the Amador County Office of the California Highway Patrol, the Amador County Office of the State Department of Transportation, the Calaveras County Local Transportation Commission, the San Andreas Office of the California Highway Patrol, the San Andreas Office of the State Department of Transportation, and the Cities of Jackson, Sutter Creek, Ione, Plymouth and Amador City. Pursuant to a staff request, copies of the application were also served on Greyhound Lines, Inc., Amador Stage Line, Inc., Mr. George Freed, dba Calaveras Transit Company, The Gray Line, Inc., and Mr. R. Scott Hartz. A protest was received on behalf of A. B. Allen, dba Allen Transportation Company, and Amador Stage Line, Inc. This protest stated that "an amendment to the application to the effect that applicants will only transport individuals participating in a round-trip tour package from points of

origin to destination, with no pickup of passengers along the designated route, would satisfy the interests of Allen Transportation and Amador Stage Lines". By letter dated March 14, 1978, applicant noted that its "tours as proposed ... are clearly round-trip packages ... No passenger is picked up at one place and left off at another". The applicants being willing to accept a certificate restricted to round-trip tours only, the order that follows will so restrict applicants' operating authority. With the adoption of this restriction, and in light of the fact that no other protests have been received, a public hearing is not necessary.

Applicants' financial statement shows assets of \$45,250, liabilities of \$25,375, and net worth of \$19,875. This would appear to be an adequate financial base from which to commence a small passenger tour service as proposed herein.

The Commission finds that:

1. Applicants are ready, willing and able to provide passenger stage service over the three proposed routes.

2. Applicants possess the personnel and financial resources to institute and maintain the proposed service.

3. Public convenience and necessity require that the application be granted.

4. It can be seen with certainty that there is no possibility that the project involved in this proceeding may have a significant effect on the environment.

The Commission concludes that the application should be granted as provided in the following order.

Applicants are placed on notice that operative rights, as such, do not constitute a class of property which may be capitalized or used as an element of value in rate fixing for any amount of money in excess of that originally paid to the State as the consideration for the granting of such rights. Aside from their purely permissive aspect, such rights extend to the holder a full or partial monopoly of a class of business. This monopoly feature may be modified or canceled at any time by the State, which is not in any respect limited as to the number of rights which may be given.

IT IS ORDERED that:

1. A Certificate of Public Convenience and Necessity (PSC-1041) is granted to Daniel Michael Dunne and Martha Janet Dunne, doing business as Gold Country Treks, authorizing them to operate as a Passenger Stage Corporation, as defined in Section 226 of the Public Utilities Code, over the routes set forth in Appendix A of this decision.

2. In providing service pursuant to the authority granted by this order, applicants shall comply with the following service regulations. Failure so to do may result in a cancellation of the authority.

- (a) Within thirty days after the effective date of this order, applicants shall file a written acceptance of the certificate granted. Applicants are placed on notice that if they accept the certificate they will be required, among other things, to comply with the safety rules administered by the California Highway Patrol, the rules and other regulations of the Commission's General Order No. 98-Series and the insurance requirements of the Commission's General Order No. 101-Series.
- (b) Within one hundred twenty days after the effective date of this order, applicants shall establish the authorized service and file tariffs and timetables, in triplicate, in the Commission's office.
- (c) The tariff and timetable filings shall be made effective not earlier than ten days after the effective date of this order on not less than ten days' notice to the Commission and to the public, and the effective date of the tariff and timetable filings shall be concurrent with the establishment of the authorized service.
- (d) The tariff and timetable filings made pursuant to this order shall comply with the regulations governing the construction and filing of tariffs and timetables set forth in the Commission's General Orders Nos. 79-Series and 98-Series.
- (e) Applicants shall maintain their accounting records on a calendar-year basis in conformance with the applicable Uniform System of Accounts or Chart of Accounts as prescribed or adopted by this Commission and shall file with the Commission on or before March 31 of each year, an annual report of its operations in such form, content and number of copies as the Commission, from time to time, shall prescribe.

SECTION 1. CENERAL AUTHORIZATIONS, RESTRICTIONS, LIMITATIONS AND SPECIFICATIONS.

Daniel Michael Dunne and Martha Janet Dunne, doing business as Gold Country Treks, by the Certificate of Public Convenience and Necessity granted in the decision noted in the margin, are authorized as a passenger stage corporation to transport passengers on sightseeing tours in Amador and Calaveras Counties, over and along the routes hereinafter described, subject, however, to the authority of this Commission to change or modify said routes at any time and subject to the following provisions:

- (a) All service herein authorized shall be limited to the transportation of round-trip tour passengers only.
- (b) Applicant shall not pick up or discharge passengers except at the points specified herein. This restrictions shall not prevent stopovers for the purpose of permitting sightseeing passengers to visit various points of interest along the route.
- (c) Motor vehicles may be turned at termini and intermediate points, in either direction, at intersections of streets or by operating around a block contiguous with such intersections, in accordance with local traffic regulations.

Commencing at the intersection of State Highway 88 and Broadway in Jackson, California, (pickup point), thence south on Broadway, Old Highway, and State Highway 49 to Center Street in Mokelumne Hill; thence via Main Street, Church, Old School Way, Lafayette and Main Street to State Highway 49; thence north on State Highway 49 to Clinton Road; thence via Clinton Road and State Highway 88 to the Community of Pine Grove; thence via the Pine Grove-Volcano Road to Volcano, (thence via Consolation and Rem's Horn Grade to Daffodil Hill and return to Volcano)*; thence south on Pine Grove-Volcano Road to the Chaw Se Indian Grinding Rocks State Historic Park.
