OPINION AND ORDER

By this application Louis H. Goselin, an individual doing business as Goselin Transportation, seeks authority pursuant to Section 3666 of the Public Utilities Code to deviate from the provisions of Minimum Rate Tariff 15. This tariff names rates and charges when a contract for services involving the exclusive use of the carrier's equipment is negotiated with the shipper.

The applicant provides a 2-axle diesel tractor for Knudsen Dairy Foods' exclusive use. The tractor is utilized to pull a set of Knudsen trailers between Fernbridge and Crescent City, Orick, Eureka and Ukiah.

The California Trucking Association, by letter to the Commission, questioned the adequacy of the applicant's cost presentation. The Commission's staff has analyzed the cost and revenue data submitted. The analysis determined that the data as submitted was adequate, and that the applicant could be expected to experience revenues sufficient to cover transportation costs and provide a reasonable margin of profit to the applicant.

The application was listed on the Commission's Daily Calendar of June 2, 1978. No other objection to the granting of the application has been received.

In the circumstances, the Commission finds that applicant's proposal is reasonable. A public hearing is not necessary. The Commission concludes that the application should be granted.

IT IS ORDERED that:

- 1. Louis H. Goselin, an individual doing business as Goselin Transportation, is hereby authorized to depart from the provisions of Minimum Rate Tariff 15 as set forth in Appendix A attached hereto and by this reference made a part hereof at not less than the rates set forth therein.
- 2. The authority granted herein shall expire one year after the effective date of this order unless sooner cancelled, modified, or extended by further order of the Commission.
