<u>O P I N I O N</u>

Lois J. Kohler operates home-to-work passenger stage service between the United Airlines Maintenance Base at the San Francisco International Airport and various specified points in the greater San Jose/Santa Clara Valley area, pursuant to Certificate of Public Convenience and Necessity PSC-387. By these applications, selected portions of this authority would be transferred to each of five transferees,¹ with the balance of the authority to be abandoned. With respect to the abandonment request (A. 58129), the application states that there "has been no demand for service" at these points "for approximately three years". Ms. Kohler cites the legalization and encouragement of van-pool operations as having "totally eliminated the need for passenger stage service between these specific points" and the United Airlines Maintenance Base.

Each of these six applications was listed in the Commission's Calendars. The Commission's Transportation Division staff has reviewed the applications and recommends that in the absence of protest or

request for public hearing, they be granted by ex parte order. No protest or request for hearing has been received. A public hearing is not necessary.

After consideration, the Commission finds that the proposed transfers and abandonment would not be adverse to the public interest and concludes that these applications should be authorized as provided herein. We find that the proposed transferees possess financial fitness to conduct passenger stage operations on the routes transferred.

The order which follows will provide for, in the event all five of the requested transfers are completed as authorized, the revocation of Ms. Kohler's present Certificate of Public Convenience and Necessity (PSC-887). However, in the event not all of the five transfers are completed, then Ms. Kohler will have remaining operating authority and obligations to the public. In that eventuality, we will, by Supplemental Order, issue a corrected Certificate to Ms. Kohler.

Lois J. Kohler and each of the first four transferees have entered into written agreements to transfer specified portions of Ms. Kohler's operating authority and the sale of bus(es). Each of these agreements recites a valuation for the bus(es), and states that: "Concurrent with this sale, seller agrees to transfer to Buyer that portion of Seller's Certificate of Public Convenience and Necessity known as ...". All transferees are placed on notice that the authorizations granted shall not be construed as findings of value for rate-making purposes of the properties authorized to be transferred by this decision.

Transferees are placed on notice that operative rights, as such, do not constitute a class of property which may be capitalized or used as an element of value in rate fixing for any amount of money in excess of that originally paid to the State as the consideration for the grant of such rights. Aside from their purely permissive aspect, such rights extend to the holders a full or partial monopoly of a class of business. This monopoly feature may be modified or cancelled at any time by the State, which is not in any respect limited as to the number of rights which may be given.

O R D E R

IT IS ORDERED that:

1. On or before October 2,1978, Lois J. Kohler may transfer the operative rights referred to in Application 57728, 57729, 57731, 57920 and 58083, to the transferees proposed therein, respectively.

2. By no later than October 2,1978, each transferee shall file with the Commission written acceptance of the certificate and a true copy of the bill of sale or other instrument of transfer.

3. By no later than October 23, 1978, each transferee shall file tariffs and timetables with the Commission, naming rates and rules governing the common carrier operations transferred to show that it has adopted or established, as its own, the applicable rates and rules of Lois J. Kohler, dba West Valley Charter Lines. The tariff and timetable filing shall be made effective November 6, 1978. The tariff and timetable filing made pursuant to this order shall comply in all respects with the regulations governing the construction and filing of tariffs and timetables set forth in the Commission's General Orders 79-Series and 98-Series. Failure to comply with the provisions of General Orders 79-Series and 98-Series may result in a cancellation of the operating authority granted by this decision.

4. In the event any of the five transfers authorized in Paragraph 1 is completed, effective November 6. 1978, a Certificate of Public Convenience and Necessity is granted to that transferee authorizing it to operate as a passenger stage corporation, as defined in Section 226 of the Public Utilities Code, as set forth in the applicable Appendix, attached hereto, and made a part hereof, as follows:

In the case of A. 58083, the proposed transferee (Whippet Charter Service, Inc.) is already a certificated passenger stage corporation; therefore, the attached Appendix E is an in lieu certificate and shall, in the event that this transfer is completed as authorized herein, replace and cancel Whippet Charter Service, Inc.'s presently effective passenger stage certificate, PSC-910.

5. Each transferee shall comply with the safety rules administered by the California Highway Patrol, the rules and regulations of the Commission's General Order 98-Series and insurance requirements of the Commission's General Order 101-Series.

6. Each transferee shall maintain its accounting records on a calendar-year basis in conformance with the applicable Uniform System of Accounts or Chart of Accounts as prescribed or adopted by this Commission and shall file with the Commission, on or before March 31 of each year, an annual report of its operations in such form, content, and number of copies as the Commission, from time to time, shall prescribe.

7. In the event all of the five authorized transfers are completed, then the Certificate of Public Convenience and Necessity granted by Decision 85057 to Lois J. Kohler is revoked, effective November 6, 1978.

8. In the event any, but not all, of the five authorized transfers is completed, then Lois J. Kohler shall continue service to all points not so transferred, in accordance with the tariffs and timetables in effect on the effective date of this order. The Commission will then issue a corrected Certificate to Ms. Kohler by Supplemental Order, formally setting forth her remaining operating authority. Transfer of any authority as herein authorized shall constitute acceptance of this order by Ms. Kohler.

SECTION 1. GENERAL AUTHORIZATIONS, RESTRICTIONS, LIMITATIONS AND SPECIFICATIONS.
