SUPPLEMENTAL OPINION AND ORDER

Decision 88837 dated May 16, 1978, in this proceeding authorized George Kishida, Inc., a California corporation, to assess a rate less than the minimum rate for the transportation of silica sand between Ione and Kingsburg for the account of Guardian Industries Corporation.

By Petition for Modification of Decision 88837, George Kishida, Inc. seeks to amend said decision to include Walter C. Webb (T-123,428), John C. Boggs (T-123,308) and Jerry M. Silva (T-123,427) as additional named subhaulers to participate in the transportation for Guardian Industries Corporation.

The petitioner has submitted revenue and cost projections for these individual subhaulers. The data is sufficient to determine that the division of revenue between George Kishida, Inc. and the aforementioned subhaulers may reasonably be expected to be profitable at the authorized rate.

The petition was listed on the Commission's Daily Calendar of July 19, 1978. California Trucking Association indicated an interest in the matter but no objections to the granting of the petition have been received.
