## ORDER OF DISMISSAL

These petitions before the Commission request that Vladimir Pantas Stepanoff, Esperanza Pantas Didasa, Bartolome Elifanio Didasa and Ferdinand Panganiban Batoon, doing business as Pacific Courier Ltd. Delivery Service be exempted from the provisions of the minimum rates for the transportation of business records, medical specimens and related articles when using motor vehicles not exceeding licensed weight of 4,500 pounds.



In Decisions 89004, 89005 and 89006, dated June 27, 1978, in Case 5432 OSH 922, Case 5439 OSH 290, and Case 5441 OSH 372, respectively, the Commission found that carriers engaged in courier service should be exempted from minimum rate regulation when transporting business records, medical specimens and related articles and whose operations have the following characteristics:

- "A. A carrier vehicle fleet consisting of only vehicles having a licensed weight of 4,500 pounds or less.
- B. Delivery shall be made within 24 hours after pickup".

There is no need for special exemption authority for this service since it is already exempt from our minimum rate regulation. Therefore, the petitions of the aforesaid parties doing business as Pacific Courier Ltd. Delivery Service are moot.

Good cause appearing,

IT IS ORDERED that Case 5432, Petition for Modification 1026 and Case 5441, Petition for Modification 409 are dismissed without prejudice.
