ORDER AMENDING DECISION NO. 89014

By Decision No. 89014 dated June 27, 1978, Federal Transportation Company (Federal) was authorized in part to:

"...transport passengers and their baggage
between Travis Air Force Base near Fairfield
on the one hand, and the Oakland Army Terminal
and the Oakland Harbor Terminal in Oakland and
Sacramento Metropolitan Airport and Oakland
International Airport on the other hand, with
intermediate stops at Davis, Vacaville, and
Vallejo over and along the route..."

Federal, in its original application, had requested to service Fairfield as an intermediate stop between Sacramento Metropolitan Airport and the Oakland Army Terminal and the Oakland Harbor Terminal. Inadvertently, Appendix A to Decision No. 89014 omitted Fairfield as an intermediate stop. There were no protests.

On July 7, 1978 applicant filed a petition for modification requesting that Decision No. 89014 be amended to include Fairfield as an intermediate stop.

Because Second Revised Page 2 of Appendix A of Decision No. 89014 was inadvertently omitted, the Commission concludes that the petition should be granted to include Fairfield as an intermediate stop between the Sacramento Metropolitan Airport on the one hand, and the Oakland Army Terminal and the Oakland Harbor Terminal on the other hand.

IT IS ORDERED that Appendix A to Decision No. 89014 is amended by substituting the attached Third Revised Page 2 for Second Revised Page 2 of Appendix A to Decision No. 89014.

The effective date of this order shall be thirty days after the date hereof.

Section 1. GENERAL AUTHORIZATIONS, RESTRICTIONS, LIMITATIONS AND SPECIFICATIONS.

Federal Transportation Co., Inc., by the Certificate of Public Convenience and Necessity granted by the decision noted in the margin, is authorized to transport passengers and their baggage between Travis Air Force Base near Fairfield on the one hand, and the Oakland Army Terminal and the Oakland Harbor Terminal in Oakland and Sacramento Metropolitan Airport and Oakland International Airport on the other hand, with intermediate stops at *Fairfield. Davis, Vacaville and Vallejo, over and along the route hereinafter described subject, however, to the authority of this Commission to change or modify said route at any time and subject to the following provision:

On Route 1

Only passengers having both origin and destination at Travis Air Force Base or at Cakland Army Terminal or at Oakland Harbor Terminal shall be transported.
