<u>OPINION</u>

Applicant is a California corporation presently operating under the authority of a highway contract carrier permit which authorizes the transportation of general commodities between all points in the State of California. Applicant also operates as a highway common carrier pursuant to a certificate of public convenience and necessity issued to it by Decision 85192 dated December 2, 1975 in Application 55802. The certificate authorizes operations over thirteen routes located in northern and central California for the transportation of general commodities in shipments weighing not more than 100 pounds, transported in vehicles of a rated capacity of one ton or less.

Applicant has applied herein to extend its certificate of public convenience and necessity to authorize operations as a highway common carrier for the transportation of general commodities, in packages weighing not more than 100 pounds, over fifty-six routes located throughout the State of California. In order to achieve greater operating efficiency, the applicant desires that the one-ton restriction on the capacity of the equipment, contained in its present certificate, be deleted from the extended certificate.

Applicant proposes to provide service in intrastate and interstate and foreign commerce, wholly within the State of California. A copy of the application was served on all known carriers operating in the area of the proposed extension, and a copy of the original application was filed with the Interstate Commerce Commission and published in the Federal Register August 17, 1978. No protests to the application have been filed.

The applicant's principal place of business is at Emeryville, California and it operates a substantial fleet of trucking equipment including 44 motor vans, 2 tractors and 3 trailers. Applicant's

balance sheet as of March 31, 1978 shows total assets of \$482,375 and total liabilities of \$473,738. Net income after tax for the year 1977 is \$50,516 out of a total operating revenue of \$1,583,643. Should the application be granted the applicant would provide daily service, Monday through Friday. Rates to be assessed will be on the same level and subject to the rules and regulations currently published and on file in West-Pak, Inc., Local Package Tariff No. 3, Cal PUC No. 2.

Applicant is presently conducting a contract operation to its permitted areas of northern and central California but the increased operations therein have possibly exceeded the scope of that authority. The applicant is ready, willing and able to provide the service proposed herein.

After consideration, the Commission finds that:

- 1. The applicant has the experience, equipment, personnel and financial resources to institute and maintain the proposed service.
- 2. Public convenience and necessity require that the applicant be authorized to engage in operations in intrastate commerce as proposed in the application and also require that the applicant be authorized to engage in operations in interstate and foreign commerce within limits which do not exceed the scope of the intrastate operations authorized by this decision.
- 3. It can be seen with certainty that there is no possibility that the activity in question may have a significant effect on the environment.
 - 4. A public hearing is not necessary.

The Commission concludes that the application should be granted as set forth in the ensuing order and a new certificate issued which will supersede the certificate previously issued. The territorial description and routes of the authority granted reflect the names of redesignated highways and roads and do not in any way exceed the geographical scope of the proposed operation as published in the Federal Register.

Applicant is placed on notice that operating rights, as such, do not constitute a class of property which may be capitalized or used as an element of value in rate fixing for any amount of money in excess of that originally paid to the State as consideration for the grant of such rights. Aside from their purely permissive aspect, such rights extend to the holder a full or partial monopoly of a class of business. This monopoly feature may be cancelled at any time by the State, which is not in any respect limited as to the number of rights which may be given.

ORDER

IT IS ORDERED that:

- 1. A certificate of public convenience and necessity is granted to West-Pak, Inc., a California corporation, authorizing it to operate as a highway common carrier, as defined in Section 213 of the Public Utilities Code, between the points and over the routes set forth in Appendix A of this decision.
- 2. In providing service pursuant to the authority granted by this order, applicant shall comply with the following service regulations. Failure to do so may result in cancellation of the authority.
 - (a) Within thirty days after the effective date of this order, applicant shall file a written acceptance of the certificate granted. Applicant is placed on notice that if it accepts the certificate it will be required, among other things, to comply with the safety rules administered by the California Highway Patrol and the insurance requirements of the Commission's General Order No. 100-Series.
 - (b) Within one hundred twenty days after the effective date of this order, applicant shall establish the authorized service and amend or file taxiffs, in triplicate, in the Commission's office.
 - (c) The tariff filings shall be made effective not earlier than thirty days after the effective date of this order on not less than thirty days' notice to the Commission and the public, and the effective date of the tariff filings shall be concurrent with the establishment of the authorized service.

- (d) The tariff filings made pursuant to this order shall comply with the regulations governing the construction and filing of tariffs set forth in the Commission's General Order No. 80-Series.
- (e) Applicant shall maintain its accounting records on a calendar year basis in conformance with the applicable Uniform System of Accounts or Chart of Accounts as prescribed or adopted by this Commission and shall file with the Commission, on or before April 30 of each year, an annual report of its operations in such form, content, and number of copies as the Commission, from time to time, shall prescribe.
- (f) Applicant shall comply with the requirements of the Commission's General Order No. 84-Series for the transportation of collect on delivery shipments. If applicant elects not to transport collect on delivery shipments, it shall make the appropriate tariff filings as required by the General Order.
- 3. The certificate of public convenience and necessity granted in paragraph 1 of this order shall supersede the certificate of public convenience and necessity granted by Decision 85192 which certificate is revoked effective concurrently with the effective date of the tariff filings required by paragraph 2(b).

The effective date of this order shall be thirty days after the date hereof.

West-Pak, Inc., by the certificate of public convenience and necessity granted in the decision noted in the margin, is authorized to conduct operations as a highway common carrier as defined in Section 213 of the Public Utilities Code for the transportation of general commodities in packages or parcels not weighing more than 100 pounds as follows:

Through routes and rates may be established between any and all points described in the authority above.

In performing the service herein authorized, carrier may make use of any and all streets, roads, highways and bridges necessary or convenient for the performance of said service.

Service shall be restricted against the transportation of traffic having a prior or subsequent movement by air between Los Angeles International Airport, on the one hand, and, on the other, the City of San Diego.

Except that pursuant to the authority herein granted carrier shall not transport any shipments of:

Used household goods, personal effects and office, store and institution furniture, fixtures and equipment not packed in
 salesmen's hand sample cases, suitcases, overnight or boston bags, brief cases, hat boxes, valises, traveling bags, trunks, lift vans, barrels, boxes, cartons, crates, cases, baskets, pails, kits, tubs, drums, bags (jute, cotton, burlap or gunny) or bundles (completely wrapped in jute, cotton, burlap, gunny, fibreboard, or straw matting).

- 2. Automobiles, trucks and buses, viz.: new and used, finished or unfinished passenger automobiles (including jeeps), ambulances, hearses and taxis, freight automobiles, automobile chassis, trucks, truck chassis, truck trailers, trucks and trailers combined, buses and bus chassis.
- 3. Livestock, viz.: barrows, boars, bulls, butcher hogs, calves, cattle, cows, dairy cattle, ewes, feeder pigs, gilts, goats, heifers, hogs, kids, lambs, oxen, pigs, rams (bucks), sheep, sheep camp outfits, sows, steers, stags, swine or wethers.
- 4. Liquids, compressed gases, commodities in semiplastic form and commodities in suspension in liquids in bulk, in tank trucks, tank trailers, tank semitrailers or a combination of such highway vehicles.
- 5. Commodities when transported in bulk in dump-type trucks or trailers or in hopper-type trucks or trailers.
- 6. Commodities when transported in motor vehicles equipped for mechanical mixing in transit.
- 7. Logs.
- 8. Fresh fruits and vegetables.
- 9. Trailer coaches and campers, including integral parts and contents when the contents are within the trailer coach or camper.
