## SUPPLEMENTAL OPINION AND ORDER CORRECTING ERROR

Decision 89429 dated September 19, 1978 in this proceeding granted authority to Garment Carriers Inc., and A & B Garment Delivery of San Francisco to merge into A & B Transportation Services, Inc., and granted to the latter an in-lieu certificate encompassing the operating authority of all three parties to the merger.

It has been brought to the attention of the Commission's staff that one of the routes shown in Appendix A of Decision 89429 was inadvertently mis-described due to the renumbering of State highways.

In the circumstances, it appears that the necessary correction should be made by the order herein and that Appendix A of Decision 89429 should be amended accordingly.

IT IS ORDERED that Decision 89429 is amended by substituting the attached First Revised Page 3 of Appendix A in place and instead of Original Page 3.

- 1. Between all points and places within San Francisco Territory as described in Note C below and within five statute miles of the boundary thereof.
- 2. Between all points and places on and within five statute miles laterally of the following highways:

  - State Highway 24 between Oakland and g. its junction with State Highway 4 near Concord, thence via State Highway 4 to Pittsburg, inclusive, including the off-route point of Moraga;
  - Interstate Highway 680 between Warm h. Springs and Martinez, inclusive;
  - State Highway 99 between Stockton and **i**. Modesto, inclusive;
