OPINION AND ORDER

By this application, Sumrise Transportation, Inc. seeks to deviate from the provisions of Minimum Rate Tariff 2 when transporting soda ash, pebble lime, salt cake and fly ash from Trona, Westend and Argus to points in California for Kerr-McGee Chemical Corporation.

Soda Ash, Salt Cake and Pebble Lime

The present and proposed rates for representative shipments, in cents per 100 pounds, of the involved commodities are:

Applicant cites the following special circumstances:

- (1) plants at both origin and destinations are open 24 hours a day;
- (2) shipments are known a week in advance which enables applicant to dispatch for virtual 24 hour a day equipment utilization; (3) the new plant expects to ship 1.45 million tons per year; (4) loading and unloading requires less than 1½ hours each.

Revenue and expense data submitted by applicant indicate that the transportation involved may reasonably be expected to be profitable under the proposed rates.

The application was listed on the Commission's Daily Calendar of November 16, 1978. No objection to the granting of the application has been received.

In the circumstances, the Commission finds that applicant's proposal is reasonable. A public hearing is not necessary. The Commission concludes that the application should be granted as set forth in the ensuing order, and the effective date of this order should be the date hereof because there is an immediate need for this rate relief.

IT IS ORDERED that:

1. Sunrise Transportation, Inc. is authorized to perform the transportation shown in Appendix A attached hereto and by this reference made a part hereof at not less than the rates set forth therein.

2. The authority granted herein shall expire one year after the effective date of this order unless sooner cancelled, modified or extended by further order of the Commission.

The effective date of this order is the date hereof.

Conditions:

- 1. Rates apply only to straight shipments of commodities named, when transported in bulk, in hopper-type equipment, gravity loaded by the shipper and unloaded by gravity or by means of pneumatic pressure.
- 2. When pneumatic equipment is ordered by the shipper and furnished by the carrier, a charge of five cents per 100 pounds shall be assessed on the weight on which transportation charges are determined, except that this charge shall not apply on shipments of fly ash.
- 3. No additional charge shall be assessed when the shipment is unloaded by gravity from pneumatic-type equipment when such equipment is utilized for the convenience of the carrier.
- 4. The rate on soda ash, salt cake and pebble lime transported to San Diego Area Metropolitan Zones 301 through 318, as described in Distance Table 8, shall be 64 cents per 100 pounds.
- 5. The rate on lime from Westend to Mendota shall be 85 cents per 100 pounds.
- 6. One-and-a-half hours is allowed for loading and one-and-a-half hours is allowed for unloading each unit of carrier's equipment.

- 7. Excess loading and/or unloading time shall be charged at \$9.00 for the first thirty (30) minutes or a fraction thereof and \$4.50 for each additional fifteen (15) minutes or a fraction thereof.
- 8. Applicant has indicated that subhaulers will not be engaged. Therefore, if subhaulers are employed, they shall be paid no less than the rates authorized herein without any deduction for use of applicant's trailing equipment.
- 9. Except as otherwise provided herein, the rules and regulations of Minimum Rate Tariff 2 shall govern, except that surcharge provisions shall not apply.
