SUPPLEMENTAL ORDER CORRECTING ERROR IN DECISION NO. 89709

The staff, upon review of Decision No. 89709 issued herein on December 12, 1978, and its work papers, has found that there was an error in the determination of rates in Decision No. 89709, and that the generated annual revenues will be more than the adopted annual revenues for 1979 and less for 1980. There was a computation error in determining rates for the second and third quantity rate blocks. As a result of such error the annual revenues are in excess by approximately \$44,700 or 0.72 percent for 1979 and deficient by approximately \$31,200 or 0.49 percent for 1980. This error should be corrected by appropriately decreasing the incorrect current rates for general metered service in 1979 and increasing the proposed rates for general metered service in 1980.

In order to rectify the error in Decision No. 89709 at the earliest time, the following order should be effective on the date of signature.

IT IS ORDERED that after the effective date of this order, Dominguez Water Corporation is authorized and directed to file the revised rate schedules attached to this order as Appendix A, page 1 of 3, and Appendix B. Such filing shall comply with General Order No. 96-A. The effective date of the revised schedules shall be four days after the date of filing. The revised schedules shall apply only to service rendered on and after the effective date thereof.

In all other respects Decision No. 89709 shall remain in full force and effect.
