OPINION AND ORDER

Applicant, Deaile Trucking Inc., requests authority to deviate from the minimum rates prescribed in Minimum Rate Tariff 2 for the transportation of chicoite (absorptive clay) from Excel Mineral Co., at Taft and McKittrick to the Metropolitan San Diego Area.

Applicant by Decision 89650 was granted authority to assess less-than-minimum rates for the transportation of chicoite from Excel Mineral Co., Taft and McKittrick, to Sacramento, the San Francisco Territory and the Metropolitan Los Angeles Area.

Chicoite is subject to a class rating of 35.4, minimum weight 40,000 pounds, pursuant to Item 48115 of the National Motor Freight Classification 100-E, and Item 1030, Exception Ratings Tariff 1. The present rate for the transportation in question is 93 cents per 100 pounds, plus applicable surcharges. Applicant proposes a rate of 73 cents per 100 pounds subject to a minimum weight of 48,000 pounds.

The application was listed on the Commission's Daily Calendar of March 21, 1979. No objection to the granting of the application has been received.

Revenue and cost data submitted by applicant indicate that the transportation involved may reasonably be expected to be profitable under the proposed rates.

In the circumstances, the Commission finds that the applicant's proposal is reasonable. A public hearing is not necessary. For the purpose of simplicity, the authority granted

by Decision 89650 should be consolidated with the granting of this application as set forth in the ensuing order. The effective date of this order should be the date hereof because there is an immediate need for this rate relief.

IT IS ORDERED that:

1. Deaile Trucking Inc. is authorized to perform the transportation shown in Appendix A attached hereto and by this reference made a part hereof.

2. The authority granted by Decision 89650 is canceled.

3. The authority granted herein shall expire one year after the effective date of this order unless sooner canceled, modified, or extended by further order of the Commission.

The effective date of this order is the date hereof.

Minimum Weight: 48,000 pounds per unit of carrier's equipment.

## Conditions:

1. Loaded by shipper.
2. Two hours will be allowed for loading and three hours for unloading. The charges for excess loading time will be as provided in Item 145 of Minimum Rate Tariff 2 for each additional one-half hour.
3. Split deliveries, not exceeding four, may be made with charges to be assessed as provided in Item 173 of Minimum Rate Tariff 2.
4. Any costs accrued for service provided during unloading operations shall be paid for by the shipper (Excel Mineral Co.).
5. Applicant has not indicated that subhaulers will be engaged nor have any costs of subhaulers been submitted. Therefore, if subhaulers are employed, they shall be paid no less than the rates authorized herein, without any deduction for use of applicant's trailing equipment.
6. In all other respects, the rates and rules in Minimum Rate Tariff 2 shall apply.
