ORDER DENYING APPLICATIONS

Each of these applications seeks, in one form or another, to modify Decision No. 88597 dated March 21, 1978, involving Cases Nos. 10107, 10142, 10204, and 10206 pertaining to the charges, practices, and procedures of all jurisdictional utilities regarding disclosure of nonpublished subscriber, credit, and toll information. By order dated June 27, 1978, in Decision No. 89051, the Commission stayed the effective date of Decision No. 88597; and by order dated April 10, 1979, the Commission directed the following:

"IT IS ORDERED that Cases Nos. 10107, 10142, 10204 and 10206 are hereby reopened.

"IT IS FURTHER ORDERED that hearings in said reopened proceedings shall be held at times to be hereafter set, before such Commissioner and Administrative Law Judge as may hereafter be assigned."

The applications to modify Decision No. 88597 have been rendered moot by the order of April 10, 1979, and should be denied without prejudice. However, applicants will be placed on the mailing list to receive copies of the Notice Setting Hearing in Cases Nos. 10107, 10142, 10204, and 10206 with the right to appear as interested parties or intervenors, as the case may be, at the hearing.

IT IS ORDERED that:

1. Applications Nos. 58009, 58011, 58015, 58018, 58019, 58036, 58086, 58142, 58212, 58237, 58296, 58367, 58372, 58404, 58447, and 58845 are denied without prejudice.

2. Applicants in the application cases set out in Ordering Paragraph 1 may appear as interested parties or intervenors, as the case may be, in Cases Nos. 10107, 10142, 10204, and 10206.

The effective date of this order shall be thirty days after the date hereof.
