FINAL OPINION AND ORDER

By Decision 89084 Adams Delivery Service, Inc., was granted interim authority to deviate from the provisions of Minimum Rate Tariff No. 2 in connection with the transportation of shipments of drugs and sundries, weighing 500 pounds or less, from Oakland to various destinations.

Finding 2 of Decision 89084 stated:

"Applicant shall develop detailed costs for the first six months of operations under this authority to be presented to the Commission within nine months from the date hereof."

Applicant has complied with this finding and the revenue and expense data indicate that the transportation involved has been and is expected to continue to be profitable under the current rates.

The Commission concludes that the authority should be continued as set forth in the ensuing order.

IT IS ORDERED that:

l. Adams Delivery Service, Inc., a corporation, is authorized to perform the transportation shown in Appendix A attached hereto and by this reference made a part hereof at not less than the charges set forth and subject to the conditions therein.

Application The charges set forth herein are applicable only to the 1. transportation of drugs and sundries in shipments weighing 500 pounds or less from Oakland to points set forth herein. The charges set forth herein apply only from the terminal 2. of Adams Delivery Service, Inc., Oakland, as proportional charges in connection with the transportation of shipments having had an immediate prior movement by highway carrier as part of a unitized shipment for subsequent reshipment by Adams Delivery Service, Inc. The provisions hereof will not apply when Adams Delivery 3. Service, Inc., provides pickup service in connection with any shipment transported. Rules l. Maximum weight per package is 100 pounds. Additional charge for C.O.D. delivery 85¢. (Package only) 2. Additional charge for corrected address 85¢. (Package only) 3. Another delivery charge will be made if the carrier is unable to deliver any shipment weighing from 101 - 500 pounds due to consignee requesting another delivery day, or it is redelivered to a correct address from an incorrect address, or shipment is refused and it is redelivered upon instructions from the shipper. Claims for loss or damage in all cases will be paid up to 5. the selling price of a single package with a maximum claim of \$100.00 dollars for any single package. Packages tied together in bundles, will be counted as a single package. The charges set forth herein, are applicable only to the 6. transportation of drugs and sundries in parcels weighing from 1 - 100 pounds and shipments weighing from 101 - 500 pounds from Oakland to all points named herein. 7. The charges herein do not apply to same day service. As used herein, the term means that no individual shipment can be delivered on the same day that it was initially picked up. -1A. 58085 APPENDIX A The charges herein, apply only from the terminal of Adams 8 -Delivery Service, Inc., in Oakland, as proportional charges in connection with the transportation of shipments having had an immediate prior movement by highway carrier other than Adams Delivery Service, Inc. or any affiliate as part of an inbound distribution service for subsequent reshipment by Adams Delivery Service, Inc. All parcels and shipments shall be prepaid by the shipper. 9. Except that the provisions of Items 176 through 179 will 10. not apply, and except as provided herein, shipments transported under the charges herein are subject to all of the provisions of Minimum Rate Tariff No. 2. On shipments received for points beyond Adams' area, on 11. which Adams advances or prepays outbound parcel charges of other carriers, Adams shall charge the shipper \$1.60 per component part in addition to the said freight charges. -2-
