S U P P L E M E N T A L O R D E R

By Decision No. 90388 dated June 5, 1979, the Commission authorized the transfer of the portion of the Certificate of Public Convenience and Necessity of Harbor Carriers, Inc. to operate as a common carrier of passengers by vessel between Long Beach and named points on Catalina Island to affiliated company H. Tourist Inc.

Among the restrictions, limitations and specifications included in the certificate to be transferred was a specification that scheduled service between the Port of Long Beach and named points on Catalina Island should be provided daily. Inadvertently this restriction was not included in the certificate issued to H. Tourist Inc. This decision will amend this omission.




IT IS ORDERED that:



(D. 90388)H. TOURIST, INC.  
(a corporation)

H. Tourist, Inc., a corporation, by the certificate of public convenience and necessity granted by the decision noted in the margin, is authorized to conduct common carrier services by vessel, as described below, for the transportation of passengers and their baggage:

I. Scheduled Service

Between the Port of Los Angeles (San Pedro) or the Port Long Beach, on the one hand, and the following points on Santa Catalina Island, on the other hand:

1. Avalon, 2. Callager's Beach, 3. Toyon Bay,
4. White's Landing, 5. Camp Fox, 6. The Isthmus,
7. Howland Landing.

Restrictions, Limitations, and Specifications:

Service between the Port of Long Beach and the points on Catalina Island shall be conducted daily.

II. Nonscheduled Service

Between Port of Los Angeles (San Pedro) or the Port of Long Beach, on the one hand, and the following points on Santa Catalina Island, on the other hand:

1. Avalon, 2. Callager's Beach, 3. Toyon Bay,
4. White's Landing, 5. Camp Fox, 6. The Isthmus,
7. Howland Landing.

Restrictions, Limitations, and Specifications:

Transportation of passengers and baggage shall not be conducted under this service unless prior arrangement based on hourly rates has been made with the carrier.
