## SUPPLEMENTAL OPINION AND ORDER

It has come to the Commission's attention that Vacating Supplement 21 of Minimum Rate Tariff 14-A does not reflect the intent of Decision No. 90584 with respect to the cancellation of supplements and the vacating of a tariff page.

IT IS ORDERED that:

- 2. Tariff publications of common carriers shall be made effective not earlier than five days after the date hereof on not less than five days' notice to the Commission and the public.
- 3. In all other respects, Decision No. 90584, as amended, shall remain in full force and effect.
- 4. The Executive Director shall serve a copy of this decision on every common carrier, or such carriers' authorized tariff publishing agents, performing transportation service subject to Minimum Rate Tariff 14-A.
