ORDER OF REVOCATION

Commission Decision No. 89601, dated October 31, 1978, granted Certificate of Public Convenience and Necessity to W. L. and H. C. Murphy, doing business as Yosemite Gold Country Stage, authorizing them to operate as a Passenger Stage Corporation, (PSC 1042), as defined in Section 226 of the Public Utilities Code, between Yosemite/Pine Mountain Lake Airport and Yosemite Valley, and over the route set forth in Appendix A of said Decision. Ordering Paragraph 2 of the Decision required applicants to satisfy the "insurance requirements of the Commission's General Order No. 101-Series" and file tariffs and timetables during the seasonal period of June through August of 1979.

On June 19, 1979, the Commission staff sent a letter to W. L. and H. C. Murphy and informed them that their timetable and tariff, received by the staff on June 14, 1979, did not comply with certain rules and regulations required by General Orders 79 and 98 A; and therefore, they were rejected. The staff requested a new filing of the tariff and timetable.

By a letter, dated July 17, 1979, the staff informed Yosemite Gold Country Stage that its required Certificate of Insurance (Form PE-610) was not filed, and gave the applicants until August 15, 1979 to supply staff with the required evidence of insurance and to establish service, or the Commission would revoke their passenger stage authority.

The applicants have not responded to either letter nor have filed their tariff, timetable, or insurance.

It appears and the Commission finds that these matters constitute good cause for the revocation of the aforementioned certificate and that such revocation would not be adverse to the public interest. The Commission, therefore, concludes that the certificate should be revoked.

IT IS ORDERED that the Certificate of Public Convenience and Necessity to operate as a passenger stage corporation authorized by Decision 89601 is hereby revoked upon the effective date of this order.
