OPINION AND ORDER

Applicant is a California corporation and a public utility warehouseman for the storage of general commodities in its warehouse located in South San Francisco. The rates, rules and regulations governing applicant's operations are contained in its Warehouse Tariffs Nos. 1 and 3, Cal. P.U.C. Nos. 1 and 3, respectively.

Applicant requests authority to increase its rates by 8 percent. The requested rate increase has been determined by applicant without consultation or agreement with any other warehouseman.

Applicant's rates were last adjusted pursuant to authority granted by Decision 89038 dated June 27, 1978 in Application 58054.

Applicant alleges that its present rates do not yield sufficient revenue to allow it to conduct its warehouse operations at a reasonable profit. The 8 percent increase in rates is within the President's wage-price guidelines.

Applicant further alleges that additional revenue is required because of increased costs in all phases of operation, the most significant being the increased cost of plant and clerical labor.

Exhibit C, attached to the application, contains revenue and expense data for the test year ended April 30, 1979 together with adjustments to reflect the proposed increase in revenue should the application be granted. The exhibit discloses that during the test year, applicant had a profit of \$3,280 after taxes and an operating

ratio of 96 percent. Projected results for the above period with expenses revised to reflect current costs without the sought rates would result in an operating ratio of 103.6 percent.

Notice of the proposed increase was sent to each of applicant's storers. No objection to the granting of the application has been received.

Findings

- 1. Applicant's rates were last adjusted by Decision 89038 dated June 27, 1978 in Application 58054.
- 2. Since applicant's rates were last adjusted, it has experienced increases in operating expenses, the most significant being the increased cost of plant and clerical labor.
- 3. Under the increase sought herein, applicant estimates it will realize additional revenue of \$11,989 and an operating ratio of 97 percent.
- 4. The proposed increases in applicant's rates and charges have been shown to be justified.
 - 5. A public hearing is not necessary.

 IT IS ORDERED that:
- 1. Pacific Coast Service Co. is authorized to establish the increased rates as proposed in Application 59223. Tariff publications authorized to be made as a result of this order shall be filed not earlier than the effective date of this order and may be made effective not earlier than five days after the effective date of this order on not less than five days' notice to the Commission and to the public.
- 2. The authority shall expire unless exercised within ninety days after the effective date of this order.

3. The authority granted by this order is subject to the express condition that applicant will never urge before this Commission in any proceeding under Section 734 of the Public Utilities Code, or in any other proceeding, that this opinion and order constitute a finding of fact of the reasonableness of any particular rate or charge. The filing of rates and charges pursuant to this order will be construed as a consent to this condition.

The effective date of this order shall be thirty days after the date hereof.
