OPINION AND ORDER

Gray Line Tours Company (Gray Line) is a passenger stage corporation providing common carrier sightseeing service. Items 710, 720, 730, and 731 of Appendix A to D.84749, as amended, set forth Gray Line's authority originating in the city of San Diego. The carrier now proposes that a new Item No. 732 containing Tour No. S-7 be added to its certificated authority applicable to San Diego, as follows:

> "Greater San Diego County Tour: This tour covers, by way of example, points of interest within that portion of San Diego County on and east of Interstate Highway 15, such as San Diego Embarcadero, Lindbergh Field, Mission Bay, Mount Soledad, U.C.S.D. Campus, Torrey Pines State Park, La Jolla, Del Mar, Cardiff by the Sea, Leucadia, San Marcos, Vista, Bonsall, Fallbrook, Escondido - Welkome Inn, Rancho Bernardo, Miramar, Mission Valley -Mission de Alcala de San Diego, and San Diego Stadium."

Gray Line's analysis of the market convinces it there is a need for the sought authority. The proposed tour would be open to sightseeing points of interest within San Diego County not presently the subject of any regulated sightseeing activity.

The proposed service would be rendered on a seasonal basis on each Tuesday, Thursday, and Saturday, June 15 through September 15 of each year. The duration of the tour would be seven hours and cover approximately 140 miles. Fares would be \$15 per adult and \$7.50 per child. Rules governing service would be as set forth in D.84749.

Gray Line is unaware of any passenger stage corporation with which the proposed service will compete. There are no protests. The application should be granted.

Findings of Fact

1. Gray Line is a passenger stage corporation engaged in performing numerous common carrier sightseeing services in California.

2. Gray Line seeks to extend its certificated sightseeing authority by adding a Greater San Diego County Tour No. S-7 in Item No. 732 of its tariff.

3. Gray Line is unaware of any passenger stage corporation with which the proposed service will compete.

4. Gray Line has the ability, financial resources, insurance, and experience necessary to perform the proposed additional sightseeing service in San Diego County.

5. The proposed fares are justified.

6. It can be seen with certainty that there is no possibility that the activity in question may have a significant effect on the environment.

7. Gray Line has demonstrated that public convenience and necessity require certification of the additional sightseeing services sought.

It is concluded that the sought authority should be granted. Since there are no protests, and since the public will benefit from immediate institution of the service, the following order should be effective the date of signature.

Gray Line is placed on notice that operative rights, as such, do not constitute a class of property which may be capitalized or used as an element of value in rate fixing for any amount of money in excess of that originally paid to the State as the consideration for the grant of such rights. Aside from their purely permissive aspect, such rights extend to the holder a full or partial monopoly of a class of business. This monopoly feature may be modified or canceled at any time by the State, which is not in any respect limited as to the number of rights which may be given.

IT IS ORDERED that:

1. Appendix A of Decision No. 84749 in Application No. 54366, as amended by Decisions Nos. 85023, 87520, 84984, and 90241, is further amended by incorporating Second Revised Page 26, attached hereto, in revision of First Revised Page 26, and First Revised Page 27, attached hereto, in revision of Original Page 27.

2. In providing service pursuant to the authority granted by this order, applicant shall comply with the following service regulations. Failure to do so may result in a cancellation of the authority.

- (a) Within thirty days after the effective date of this order, applicant shall file a written acceptance of the certificate granted. Applicant is placed on notice that if it accepts the certificate it will be required, among other things, to comply with the safety rules of the California Highway Patrol, the rules and other regulations of the Commission's General Order No. 98-Series, and the insurance requirements of the Commission's General Order No. 101-Series.
- (b) Within one hundred twenty days after the effective date of this order, applicant shall establish the authorized service and file tariffs and timetables, in triplicate, in the Commission's office.
- (c) The tariff and timetable filings shall be made effective not earlier than ten days after the effective date of this order on not less than ten days' notice to the Commission and the public, and the effective date of the tariff and timetable filings shall be concurrent with the establishment of the authorized service.
- (d) The tariff and timetable filings made pursuant to this order shall comply with the regulations governing the construction and filing of tariffs and timetables set forth in the Commission's General Orders Nos. 79-Series and 98-Series.

(e) Applicant shall maintain its accounting records on a calendar year basis in conformance with the applicable Uniform System of Accounts or Chart of Accounts as prescribed or adopted by this Commission and shall file with the Commission, on or before March 31 of each year, an annual report of its operations in such form, content, and number of copies as the Commission, from time to time, shall prescribe.
