## OPINION AND ORDER

By this application, Western Motor Tariff Bureau, Inc., Agent (WMTB) seeks authority on behalf of Crescent Truck Lines (Crescent) to participate in Item 298 of WMTB's Local, Joint and Proportional Freight and Express Tariff No. 111, Cal. P.U.C. No. 15 (WMTB 111), and concurrently cancel the carrier's participation in Item 314 of the aforesaid tariff.

Applicant states that WMTB lll contains two items, 298 and 314, respectively, pertaining to the assessment of charges by a carrier when a shipper, tendering high cubic volume low density shipments, utilizes one or more units of a carrier's equipment for its transportation needs. Crescent contends that Item 298 is more equitable to both shipper and carrier, since the provisions of the rule set forth more precise means by which charges, based upon the lineal feet of loading space of the vehicle utilized, are assessed. In contrast, Item 314 sets forth more general provisions which provides the carrier a somewhat lesser amount of freight revenue, for example, when transporting shipments of light and bulky commodities.

Applicant has been advised that in the event the application is granted and the resulting tariff publications are made, such publications will not increase the California intrastate gross revenue of Crescent by as much as one percent.

The application was listed on the Commission's Daily Calendar of October 15, 1979. No objection to the granting of the application has been received.
