ORDER OF DISMISSAL

These three applications contain requests for original certificates to perform common carrier passenger stage service between Los Angeles International Airport and various points in southern California.

A.56916, et al. EA/ks

Public hearing in A.56916 and A.56980 was held before Administrative Law Judge Norman B. Haley at Los Angeles on January 19, 20, and 21, 1977. Those applications were taken off calendar because the United States District Court, Southern District of California, entered an order in Bankruptcy Chapter XI Proceedings, Cases 76-3054 and 76-3065AK (Airportransit, Inc.), restraining the Commission, as well as the two applicants, from proceeding with the applications beyond January 21, 1977.

Public hearing in A.57004 was held before Administrative Law Judge Charles Mattson at Los Angeles on July 21, 1977. That matter was taken off calendar on motion for consolidation with A.56916 and A.56980.

The matter of common carrier airport bus transportation between the points involved in these three applications was substantially disposed of in a subsequent certificate transfer matter (D.90383 (1979) in A.58082). In that decision the receiver in bankruptcy for Airportransit, Inc., and Airport Service, Incorporated, were authorized to transfer to Airport Service, Incorporated, the Southern Region passenger stage certificate formerly granted to Airportransit, Inc. by D.78126 (1970). That certificate authorized airport bus service between Los Angeles International Airport and hotels and other bus stops in downtown Los Angeles, Hollywood, West Los Angeles, San Fernando Valley, Inglewood/Hawthorne, Commerce, and other locations in Los Angeles, Riverside, and San Bernardino counties. D.90383 also authorized Airport Service, Incorporated, to suspend service on certain of the routes transferred to it.

By letter dated November 12, 1979, attorney for The Gray Line Tours Company expressed the desire that A.56916 and A.57004 be dismissed. By letter dated November 14, 1979, attorney for Airport Service, Incorporated, authorized dismissal of A.56980. A.56916, et al. EA/ks

The Commission concludes that A.56916, A.56980, and A.57004 should be dismissed.

IT IS ORDERED that Applications Nos. 56916 and 57004, filed by The Gray Line Tours Company, and Application No. 56980, filed by Airport Service, Incorporated, are dismissed.

The effective date of this order shall be thirty days after the date hereof.
