ORDER OF REVOCATION

Commission Decision No. 90456, dated June 19, 1979, granted Certificate of Public Convenience and Necessity to Steven Norris Andrews authorizing him to operate as a Passenger Stage Corporation, PSC 1073, as defined in Section 226 of the Public Utilities Code, transporting rafters and their rafts along the American River in Sacramento County between downstream Watt Avenue Bridge and the upstream Sunrise Boulevard Bridge, and over the route set forth in Appendix A of said Decision.

Ordering Paragraph 2 of the Decision required applicant to satisfy the "insurance requirements of the Commission's General Order No. 101-Series" and file tariffs and timetables during the period from June 29, 1979 to October 17, 1979.

On June 21, 1979, the Commission staff sent a letter to Mr. Andrews and requested him to file a written acceptance of the certificate not later than July 19, 1979, tariff, timetable and a Certificate of Insurance not later than October 17, 1979. The letter cautioned him of the Paragraph 2 of the order which states "Failure so to do may result in a cancellation of the authority".

By a letter, dated October 30, 1979, the Commission staff informed Mr. Andrews that he had not responded to the letter of June 21, 1979, nor had he filed the required documents. Mr. Andrews was informed that unless he complied with all the filing requirements by November 30, 1979, the Commission would revoke his Passenger Stage authority.

The applicant has not responded to either letter nor has filed his tariff, timetable, or insurance as of this date.

It appears and the Commission finds that these matters constitute good cause for the revocation of the aforementioned certificate and that such revocation would not be adverse to the public interest. The Commission, therefore, concludes that the certificate should be revoked.

IT IS ORDERED that the Certificate of Public Convenience and Necessity to operate as a passenger stage corporation authorized by Decision 90456 is hereby revoked upon the effective date of this order.
