SUPPLEMENTAL OPINION AND ORDER

It has come to the Commission's attention that Supplement 9 to Minimum Rate Tariff 12-A does not reflect the intent of Decision 91264 with respect to the application of surcharges in connection with various items of the tariff. The surcharge which should have been increased to 6 1/2 percent was inadvertently left at 5 3/4 percent.

IT IS ORDERED that:

- 1. Minimum Rate Tariff 12-A (Appendix A of Decision 85573, as amended) is further amended by incorporating therein, to become effective March 5, 1980, Supplement 10, attached hereto and by this reference made a part hereof.
- 2. Tariff publications of common carriers shall be made effective not earlier than March 5, 1980, on one day's notice to the Commission and to the public.
- 3. In all other respects, Decision 91264, as amended, shall remain in full force and effect.
- 4. The Executive Director shall serve a copy of this decision on every common carrier, or such carriers' authorized tariff publishing agents, performing transportation services subject to Minimum Rate Tariff 12-A.

__SUPPLEMENT 10 TO MINIMUM RATE TARIPF 12-A

OAPPLICATION OF SURCHARGE

Except as otherwise provided, compute the amount of charges in accordance with the rates and rules in this tariff, and increase the resulting total amount by six and one-half (64) percent. (See Exception)

For purpose of disposing of fractions under provisions hereof, fractions of less than one-half (3) cent shall be dropped and fractions of one-half (3) cent or greater shall be increased to the next higher whole cent.

EXCEPTION: The surcharge herein shall not apply to:

- 1. Item 130 Split Pickup:
- 2. Item 140 Split Delivery
- Item 150 Special Loading and unloading charges;
- 4. Item 160 Payment of Advance Charges;
- 5. Items 180, 190, 200 and 210 (Railhead-to-railhead Charges only);
- 6. Item 220 Accessorial Service Charges;
- 7. Item 232 Special C.O.D. Service;
- 8. Item 235 Collect on Delivery (C.O.D.) Shipments.
