It has come to the Commission's attention that Decision 91831 does not reflect the intent of said decision with respect to the application of surcharges to cottonseeds.


Pursuant to Resolution A-4661,

IT IS ORDERED that:

1. Minimum Rate Tariff 14-A (Appendix A to Decision 67397, as amended) is further amended by incorporating therein, to become effective June 8, 1980, Supplement 29 attached hereto and by this reference made a part hereof.
2. Tariff publications of common carriers shall be made effective not earlier than June 8, 1980 on one day's notice to the Commission and to the public.
3. In all other respects, Decision 91831, as amended, shall remain in full force and effect.

The effective date of this order is the date hereof.

APPLICATION OF SURCHARGE

Except as otherwise provided, compute the amount of charges in accordance with the rates and rules of this tariff, and increase the resulting total amount as follows:

1. by fourteen (14) percent on rates applicable to cottonseed,
2. by twenty-two (22) percent on all other rates and charges. (See Exception.)

For purposes of disposing of fractions under provisions hereof, fractions of less than one-half (1/2) cent shall be dropped and fractions of one-half (1/2) cent or greater shall be increased to the next higher whole cent.

EXCEPTION: The surcharge herein shall not apply to:

1. Item 120 - Delays to Equipment;
2. Item 135 - Charges for Obtaining a Weighmaster's Certificate;
3. Item 170 - Split Pickup or Split Delivery Charges;
4. Item 190 - Stopping in Transit;
5. Items 200 and 210 - Railhead-to-railhead charges only);
6. Item 232 - Collect on Delivery (C.O.D.) Shipments.
