ORDER OF REVOCATION

Commission Decision No. 87723, dated August 16, 1977, granted a Certificate of Public Convenience and Necessity to Caritas Creek, a non-profit California corporation to operate as a Passenger Stage Corporation (PSC-1019) to transport children between the ages of 7 through 17 between the Counties of Solano, San Francisco, San Mateo, Marin, Santa Clara, Alameda, Contra Costa, Napa, Sonoma, and Sacramento on the one hand, and Mendocino Woodlands, Camp 3, Mendocino County on the other hand.

Ordering Paragraph 2 of the Decision required applicant to satisfy the "insurance requirements of the Commission's General Order 101-Series."

On December 11, 1978, the Commission staff sent a letter to Caritas Creek suspending its Passenger Stage Corporation Certificate (PSC-1019) for lack of insurance.

On February 27, 1980, the Commission staff sent a letter to Caritas Creek noting that its PSC certificate had been under suspension since December 11, 1978 due to lack of insurance and that unless it filed the required insurance, the Commission staff would commence proceedings to permanently revoke its certificate.

The applicant has not responded to the letter of February 27, 1980 and has not had insurance on file with the Commission since December 10, 1978.

It appears and the Commission finds that these matters constitute good cause for the revocation of the aforementioned certificate and that such revocation would not be adverse to the public interest. The Commission, therefore, concludes that the certificate should be revoked.

O R D E R

IT IS ORDERED that the Certificate of Public Convenience and Necessity to operate as a Passenger Stage Corporation authorized by Decision 87723 is hereby revoked upon the effective date of this order.






