ORDER OF REVOCATION

Commission Decision No. 91250, dated January 15, 1980, granted a Certificate of Public Convenience and Necessity to Diablo Airporter, a partnership composed of Hugh J. Reilly, Michael L. LeBreck, and William A. Hanson, to operate as a Passenger Stage Corporation (PSC-1101) between Alamo, Danville, and Dublin, on the one hand, and Oakland International Airport and San Francisco International Airport, on the other hand.

Ordering Paragraph 2 of the Decision required the applicant to file a written acceptance of the certificate by February 14, 1980, file tariffs and timetables by May 2, 1980, and satisfy the insurance requirements of the Commission's General Order No. 101-Series.

On January 25, 1980, the Commission staff sent the applicant a letter reiterating the requirements in the ordering paragraphs of the Decision and noted that the Decision cautioned that failure to comply may result in a cancellation of the authority.

On March 10, 1980, the Commission staff sent the applicant a letter reminding the applicant that the deadline has passed to file the written acceptance of the certificate and that if the Commission does not receive this acceptance, the Commission staff will have to recommend that the passenger stage certificate be revoked. The applicant has not responded to the two above-mentioned letters and, in fact, has not sent any correspondence to the Commission since Decision No. 91250 was granted on January 15, 1980.

It appears and the Commission finds that these matters constitutes good cause for the revocation of the aforementioned certificate and that such revocation would not be adverse to the public interest. The Commission, therefore, concludes that the certificate should be revoked.

O R D E R

IT IS ORDERED that the Certificate of Public Convenience and Necessity to operate as a Passenger Stage Corporation authorized by Decision No. 91250 is hereby revoked upon the effective date of this order.
