By Decision Number 85561, dated March 16, 1976, Valen Parking Management, Inc., doing business as The Town Tour (Funbus) Co., was issued a certificate of public convenience and necessity to operate as a passenger stage corporation (PSC-918) between points within the County of Orange, and certain territories intermediate and adjacent thereto, and between points in Orange County, on the one hand, and Los Alamitos Race Track in Orange County, Hollywood Park Race Track, The Forum, and Los Angeles Coliseum and Sports Arena, in Los Angeles County, on the other hand. Included in the routes the company operates is Poute No. 6* which is the subject of this application.

The Commission in its Resolution No. PE-354 dated October 25, 1977 changed Commission records to reflect the corporate name change of the carrier from Valen Parking Management, Inc. to: The Town Tour Funbus Co., Inc. Inasmuch as the order that follows will necessarily include a revision to the carrier's Certificate of Public Convenience and Necessity (PSC-918) this seems an appropriate time to reissue the certificate in its entirety to indicate the new corporate name. Accordingly, a revised Appendix A of Decision No. 85561 in Application No. 55427 will be attached

*Route No. 6 - HOLLYWOOD PARK RACE TRACK - THE FORUM

Commencing at the Disneyland Hotel, 1150 West Cerritos Ave. Anaheim, thence connecting with Routes Nos. 1 and 2 hereof and over the most convenient and appropriate streets and freeways to the Hollywood Park Race Track and/or to The Forum. A. 59443 - T/avm

hereto and made a part hereof to effect the name change as well as the deletion of the operating authority being transferred as a result of the instant application.

By this application, The Town Tour Funbus Co., Inc. hereinafter referred to as seller, requests authority pursuant to Section 851, et seq., of the Public Utilities Code to transfer the portion of its certificate of public convenience and necessity above described to Commuter Bus Lines, Inc., hereinafter referred to as purchaser. Seller will retain the portion of this route pertaining to the Forum as well as all other routes presently held by it in its certificate (PSC-918) authorizing operations as a Passenger Stage Corporation.

The seller and purchaser have entered into a written agreement on the terms and conditions for transfer of the certificate. The parties have agreed that the purchase price will be the sum of \$1,000, for certificated rights described above.

In this application, Commuter Bus Lines, Inc. has also requested a minor route change and inclusion of the right to serve Leisure World on the way to/from Hollywood Park Pace Track. The carrier was notified by letter dated March 4, 1980 that such requests should be handled separately, and at a later date, after the transfer application has been completed. By letter to the Commission dated March 20, 1980, Commuter Bus Lines, Inc. has acknowledged that these other matters may be pursued by filing a separate application at a later date, in order that this application may be processed expeditiously. Accordingly, the order that follows will only incorporate the addition of the route acquired from The Town Tour Funbus Co., Inc.

Further, with regards to Commuter Bus Lines, Inc., the Commission in its Resolution No. PE-379 dated May 6, 1980 changed Commission records to reflect the corporate name change of the carrier from Douglas Bus Lines, Inc. to: Commuter Bus Lines, Inc. Inasmuch as the carrier in a letter to the Commission dated March 20, 1980 stated that it plans to file for an in-lieu certificate in the

foreseeable future and inasmuch as the carrier's operating rights involve voluminous records to be changed, the certificate revision issued as the result of the instant application will be the only change shown in this carrier's Certificate of Public Convenience and Necessity at this time. Such change will be shown on First Revised Page 10 to Appendix G of the certificate issued to Commuter Bus Lines, Inc. (PSC-453), attached hereto and made a part hereof.

The application was listed on the Commission's Daily Calendar of February 14, 1980. The Commission's Transportation Division staff has reviewed the application and recommends that in the absence of protest or request for public hearing, it be granted by ex parte order. No protest or request for hearing has been received. A public hearing is not necessary.

After consideration the Commission finds that the proposed transfer would not be adverse to the public interest and concludes that it should be authorized.

The order which follows will provide for, in the event the transfer is completed, the revision of the certificate presently held by The Town Tour Funbus Co., Inc. (PSC-918) and the revision of the certificate in appendix form issued to Commuter Bus Lines, Inc. (PSC-453).

Purchaser is placed on notice that operative rights, as such, do not constitute a class of property which may be capitalized or used as an element of value in rate fixing for any amount of money in excess of that originally paid to the State as the consideration for the grant of such rights. Aside from their purely permissive aspect, such rights extend to the holder a full or partial monopoly of a class of business. This monopoly feature may be modified or canceled at any time by the State, which is not in any respect limited as to the number of rights which may be given.

<u>ORDER</u>

IT IS ORDERED that:

1. On or before August 1, 1980, The Town Tour Funbus, Co., Inc. may sell and transfer the operative rights referred to in the application to the purchaser Commuter Bus Lines, Inc.

2. Within thirty days after the transfer, the seller and the purchaser shall file with the Commission written acceptance of the revised certificates and a true copy of the bill of sale or other instrument of transfer.

Purchaser and seller shall amend or reissue the tariffs 3. and timetables on file with the Commission, naming rates and rules governing the common carrier operations transferred to show that $\frac{1}{2}$ has adopted or established, as its own, the rates and rules. The tariff and timetable filings shall be made effective not earlier than five days after the effective date of this order on not less than five days' notice to the Commission and the public, and the effective date of the tariff and timetable filings shall be concurrent with the transfer. The tariff and timetable filings made pursuant to this order shall comply in all respects with the regulations governing the construction and filing of tariffs and timetables set forth in the Commission's General Orders Nos. 79-Series and 98-Series. Failure to comply with the provisions of General Orders Nos. 79-Series and 98-Series may result in a cancellation of the operating authority granted by this decision.

4. In the event the transfer authorized in paragraph 1 is completed, effective concurrently with the effective date of the tariff filings required by paragraph 3, the revised certificate of public convenience and necessity is granted to Commuter Bus Lines, Inc. authorizing it to operate as a passenger stage corporation, as defined in Section 226 of the Public Utilities Code, between the points and over the routes set forth in Appendix G, (PSC-453) attached hereto and made a part hereof.

5. The certificate of public convenience and necessity granted to The Town Tour Funbus Co., Inc. is revised as shown in Appendix A (PSC-918) attached hereto, effective concurrently with the effective date of the tariff filings required by paragraph 3.

The effective date of this order shall be thirty days after the date hereof.

SECTION 1. GENERAL AUTHORIZATIONS, RESTRICTIONS, LIMITATIONS, AND SPECIFICATIONS.

Valen Parking Management, Inc., doing business as The Town Tour (Funbus) Co., Inc., by the certificate of public convenience and necessity granted by the decision noted in the margin, is authorized to transport passengers between points within the County of Orange, and certain territories intermediate and adjacent thereto, and between points in Orange County, on the one hand, and Los Alamitos Race Track in Orange County, Hollywood Park Race Track, the Forum, and Los Angeles Coliseum and Sports Arena, in Los Angeles County, on the other hand, over and along the routes hereinafter described, subject, however, to the authority of this Commission to change or modify said routes at any time and subject to the following provisions.

- (a) Motor vehicles may be turned at termini and intermediate points, in either direction, at intersections of streets or by operating around a block contiguous to such intersections, in accordance with local traffic regulations.
- When route descriptions are given in one (b) direction, they apply to operation in either direction, unless otherwise directed.
- Service on Routes Nos. 1 and 2 shall be (c) available in coordination with events at the Los Alamitos Race Track, Hollywood Park Race Track, The Forum, Los Angeles Coliseum and Sports Arena, and Los Angeles Dodger Stadium.
- Service on Route No. 2, shall be available (đ) in coordination with events at the Convention Center.
- (e) Service on Route No. 3, Stadium-East Katella Ave., is available for regularly scheduled night, day, or special event baseball games of the California Angels at the Anaheim Stadium.
- (f) Service on Route No. 4, Anaheim-Buena Park, shall be operated seven days per week except Christmas.
