## OPINION AND ORDER

By this application, O. R. Thomasson, Alternate Agent, Pacific Motor Tariff Bureau, Inc. (PMTB), on behalf of James William Livesay, dba Golden Bay Freight Lines (Golden Bay), seeks authority to cancel carrier's participation in the tariff provisions of small shipment service as published in certain tariffs of Pacific Motor Tariff Bureau, Inc. 1

Golden Bay states that it needs to "protect itself as to proper minimum revenue requirements." Therefore, it seeks to cancel its participation in these tariff provisions, and apply "standards as set forth elsewhere in its tariffs."

Specifically Golden Bay seeks to cancel its participation in Item 1600 of Local Freight Tariff No. 17, Cal. P.U.C. No. 17 and Item 865 of Local Freight and Express Tariff No. 8-A, Cal. P.U.C. No. 1 (Series of D. W. Baker, Agent), of Pacific Motor Tariff Bureau, Inc.

Applicant states that the proposed changes would increase Golden Bay's yearly revenue by approximately \$10,000, and that if the application is granted it would not increase carrier's gross revenue on intrastate traffic by as much as one percent. The amount of increase is within the President's wage-price guidelines. Authorization is sought under Sections 454 and 491 of the Public Utilities Code.

The application was listed on the Commission's Daily Calendar of May 28, 1980. No objection to the granting of the application has been received.

In the circumstances, the Commission finds that the proposed changes are justified. A public hearing is not necessary. The Commission concludes that the application should be granted as set forth in the ensuing order, and the effective date of this order should be the date hereof because there is an immediate need for this rate relief.

## IT IS ORDERED that:

- 1. O. R. Thomasson, Alternate Agent, is hereby authorized on behalf of James William Livesay, dba Golden Bay Freight Lines, to publish amendments to Item 1600 of Local Freight Tariff No. 17, Cal. P.U.C. No. 17 and Item 865 of Local Freight and Express Tariff No. 8-A, Cal. P.U.C. No. 1 (Series of D. W. Baker, Agent), Pacific Motor Tariff Bureau, Inc., as specifically proposed in the application.
- 2. Tariff publications authorized to be made as result of the order herein shall be filed not earlier than the effective date of this order and may be made effective not earlier than five days after the effective date of this order on not less than five days' notice to the Commission and to the public.
- 3. The authority herein granted shall expire unless exercised within ninety days after the effective date of this order.
