## ORDER OF REVOCATION

Commission Decision No. 82982, dated June 18, 1974, granted a Certificate of Public Convenience and Necessity to Bob Brown's Ski and Sport Shops, Inc., a California Corporation, authorizing it to operate as a Passenger Stage Corporation, PSC-934, as defined in Section 226 of the Public Utilities Code, transporting passengers and their baggage during the winter snow season between Contra Costa County Ski Shops, on the one hand, and the Kirkwood Meadows Ski Area and Bear Valley Ski Area, on the other hand.

Commission Decision No. 85645, dated March 30, 1976, authorized the carrier to extend its passenger stage operation by the addition of the two East Bay pickup points to its service area authority which was granted by Decision No. 82982.

Ordering paragraph 3 of Decision 85645 required applicant to comply with certain service regulations of the Commission's General Order 98-Series and insurance requirements of the Commission's General Order No. 101-series.

The carrier's authority to transport passengers has been suspended by the Commission as of November 26, 1978, because of the termination of its liability insurance.

The Commission's correspondence with the carrier has been returned by the Post Office, marked "not deliverable as addressed, unable to forward."

As the result of several telephone calls, it appears to the Transportation Division staff that Bob Brown no longer owns the Ski and Sport Shops, or operates a Passenger Stage Corporation.

It appears and the Commission finds that these matters constitute good cause for the revocation of the aforementioned certificate and that such revocation would not be adverse to the public interest. The Commission, therefore, concludes that the certificate should be revoked.

IT IS ORDERED that the Certificate of Public Convenience and Necessity to operate as a passenger stage corporation authorized by Decisions 82982 and 85645 is hereby revoked upon the effective date of this order.
