## ORDER OF REVOCATION AND DISMISSAL

In Application 57402, Mission Trails Charter Service, Inc. requested authority to purchase the Passenger Stage Certificate (PSC-911) and six buses from Falcon Charter Service, Inc. Decision 87762 dated August 23, 1977 authorized the transfer on an interim basis.

Decision 91170 dated December 18, 1977 in Application 59117 amended and reissued the certificate.

Decision No. 91458 dated March 18, 1980 in Application 57402 made that interim certificate permanent.

Application 59325 requests authority to increase the fares for the service from \$16.00 to \$19.75 for ten rides.

On April 16, 1980 San Mateo County Transit District (District)

filed a complaint in eminent domain in the San Mateo County Superior Court seeking to acquire certain assets of Mission Trails including its operating rights under its certificate of public convenience and necessity as a passenger stage corporation, its corporate name, and its right, title, and interest to specified buses.

On May 15, 1980 Judge Thomas M. Jenkins, Judge of the Superior Court of the County of San Mateo, issued a Final Order of Condemnation finding that the property described in the complaint to be condemned and taken by the District for the public use.

The District is not under our jurisdiction, so far as fares, service or insurance requirements are concerned.

On June 4, 1980, the Commission received notice of cancellation of the Public Liability and Property Damage Insurance of Mission Trails effective July 7, 1980.

## ORDER

## IT IS ORDERED that:

- 1. The interim certificate of public convenience and necessity (PSC-911) transferred to Mission Trails Charter Service, Inc., as authorized by Decision 87762 in Application 57402, revised and reissued by Decision 91170 in Application 59117 and made permanent by Decision 91458 in Application 57402, is hereby revoked.
- 2. All tariffs and timetables presently on file with this Commission in the name of Mission Trails Charter Service, Inc. are cancelled.
  - 3. Application 59325 is dismissed without prejudice.
