SUPPLEMENTAL OPINION AND ORDER

Decision 92039 dated July 15, 1980 in Application 59492, as amended, granted an extension of cement carrier authority and an in-lieu certificate of public convenience and necessity to Richard N. Ladeira, an individual doing business as Richard N. Ladeira Trucking. The certificate authority is described in Appendix "A" of said decision.

The Commission has now been informed that a typographical error occurred in the wording of Restriction 2 of the certificate authority. That restriction contains an "alter ego" provision which governs the lowest rates and charges which must be paid to subhaulers engaged by the above-named carrier to transport property in which Richard N. Ladeira Trucking has a direct or indirect financial interest.

In the circumstances, the Commission finds that the necessary correction should be made by the order herein and that Appendix "A" of Decision 92039 should be amended accordingly. The Commission concludes that the effective date of this order should be the date on which it is signed, since there is no reason to delay correcting the discrepancy.

IT IS ORDERED that Appendix "A" of Decision 92039 be amended by substituting First Revised Page 1 attached hereto in place and instead of Original Page 1.
