ORDER MODIFYING DECISION NO. 84062

Decision No. 82139 dated November 13, 1973, an Interim Order in Case No. 9581 et al, required all respondent electric utilities to provide progress reports every 15 days with respect to the effectiveness of their usage reduction programs. This requirement was further modified in Decision No. 84062 dated February 11, 1975. All respondent electric utilities were then ordered to provide progress reports monthly beginning with January 1975.

In the last six years the utilities have provided very valuable information. The random sample of customers' usage data submitted by the utilities confirms our belief of the effectiveness of ongoing conservation programs. The utilities also provide similar information during rate case proceedings or when requested by the Commission staff. As mandated by the Commission, the information on an annual basis is also provided by the utilities in their reports on energy conservation activities.

The Commission and its staff, after studying the past five years' historical data, have determined that the Commission no longer requires the monthly reports filed pursuant to Ordering Paragraph 3 of Decision No. 84062. However, we expect the utilities to cooperate as they have done in the past in providing similar information when requested. As new programs evolve, we will request other kinds of information which we believe are better suited to our current needs. This modification is minor in nature and deals only with filing requirements instituted to assist the Commission and its staff.

The Commission finds that the periodic reports required by Ordering Paragraph 3 of Decision No. 84062 are no longer necessary.

The Commission concludes that Ordering Paragraph 3 of Decision No. 84062 should be modified to delete the requirement that such periodic reports be filed.

The following order should be effective on the date of signature so that utilities may discontinue the filing of reports on January 1, 1981.

IT IS ORDERED that:

1. Decision No. 84062 in this proceeding is amended by deleting Ordering Paragraph 3 of that decision, as of January 1, 1981.

2. In all other respects Decision No. 84062 remains in full force and effect.

The effective date of this order is the date hereof.
