O P I N I O N

Mary Jeanne VanDeventer (MJVD), dba Rancho Las Palmas Caravans or Caravan Tours, seeks a certificate of public convenience and necessity pursuant to the provisions of Sections 1031 and 1032 of the Public Utilities Code to establish and operate a common carrier passenger stage service for 24 sightseeing tours of the Palm Springs area as follows:

- Tour 1 Hot Air Balloon Caravan - tour to Sunrise Balloon Company in La Quinta for balloon rides.  
7:00 a.m. to 9:30 a.m.      \$88.00 per person
- Tour 2 Cross Country Ski Caravan - tour to the top of Mt. San Jacinto for cross-country ski tour - winter months only.  
1:30 p.m. to 5:00 p.m.      \$42.00 per person
- Tour 3 Fisherman's Fantasy Caravan - tour to the Whitewater Fish Hatchery for fishing trip. Also, fishing trip to Lake Hemet upon request.  
1:30 p.m. to 5:00 p.m.      \$33.00 per person

- Tour 4 Happy Trails Caravan - tour to Smoketree Stables in Palm Springs for choice of 1-hour or 2½-hour trail rides.

- Tour 13 Callaway Winery Caravan - tour to the Callaway Winery in Temecula, with wine tasting, tour of winery, and outdoor luncheon barbecue.

- Tour 14 Aerial Tram Caravan - tour to the Palm Springs Aerial Tramway, with nature walk atop the Mountain Station, followed by wine and cheese party or refreshments at the Mountain Station, optional Celebrity Home Tour.

- Tour 15 Palm Desert Caravan - tour of Living Desert Reserve, Date Shakes at Indian Wells Date Garden, and shopping on the El Paseo.

- Tour 16 Beauty Break Caravan - tour to the Palms in Palm Springs for luncheon and fitness program.

- Tour 17 Palm Springs Caravan - tour of the Celebrity Homes in Palm Springs, guided tour of the Desert Museum, shopping in downtown Palm Springs, and tour of Moorten's Botanical Garden with wine and cheese party in Garden.

- Tour 18 Decorator Mini Caravan - tour of Model Homes at the Springs Club, Mission Hills Country Club, Del Safari Country Club, Casas de Seville, Los Lagos, and Desert Horizons Country Club.

- Tour 19 Palm Springs Cabaret Caravan - tour via chauffeur-driven limousines to four night-clubs in Palm Springs, including cocktails at each club.  
9:30 p.m. to 12:00 midnight \$42.00 per person
- Tour 20 Idyllwild High Country Caravan - tour to Idyllwild, California, for a stained glass demonstration at artist's private studio, a ceramics exhibit and demonstration at artist's studio, and lunch at the Baker in the Forest Restaurant.  
1:30 p.m. to 5:30 p.m. \$33.00 per person
- Tour 21 Country Club Caravan - tour to two country clubs in the Rancho Mirage area for lunch and dessert, along with tour of model homes.  
11:30 a.m. to 3:00 p.m. \$52.00 per person
- Tour 22 Mexican Fiesta Caravan - tour of Las Casuelas Terraza Restaurant with presentation on Mexican cooking and luncheon.  
11:00 a.m. to 3:00 p.m. \$36.00 per person
- Tour 23 Far Eastern Ecstasy Caravan - tour to Kobe's Japanese Steak House for luncheon, followed by Japanese Shiatsu Massage at Canyon Spa.  
12:00 noon to 4:00 p.m. \$46.00 per person
- Tour 24 Snowbird Caravan - tour to Snow Summit and Snow Valley for downhill skiing, Big Bear, California.  
7:00 a.m. to 6:00 p.m. \$76.00 per person

MJVD proposes to provide pick-up service in Riverside County, including Marriott's Rancho Las Palmas Resort in Rancho Mirage, California, and proceed to the starting points of the 24 tours. It is proposed that tours 1 through 8 will require a minimum of six passengers and the remaining 16 tours will require a minimum of 30 passengers. A guarantee of the number of participants is requested 24 to 48 hours in advance of a tour and a cancellation charge may apply if a tour is canceled less than 24 hours in advance.

MJVD has been in the resort business for six years, employed by such corporations as the Marriott Hotels, Golf Hosts West, and LTV Corporation to perform functions related to sales manager, public relations manager, and marketing manager. She has a bachelor of arts degree in advertising and public relations, with a minor in business marketing. The financial statement included with the application lists her current assets as \$33,937 with total liabilities of \$7,900 and a net worth of \$21,137. The projected annual income statement included with the application shows operating revenues of \$96,000 for 160 tours with 4,800 passengers, operating expenses of \$78,960, and a net operating income of \$17,040.

The names of the passenger stage lines now operating between any of the points to be served are listed by MJVD to be Gray Lines, Inc., Palm Springs Celebrity Tours, and Country Club Limousines. These companies were furnished copies of the application, forwarded by mail on the date of the application. Further, the application was listed on the Commission's Daily Calendar on October 10, 1980. No protest or request for hearing has been received.

MJVD does not own nor does she propose to own any motor vehicles to be used in the operation of these tours. All vehicles required will be leased from a licensed motor coach charter company or a vehicle leasing company. The equipment used will depend on the number of participants on each tour. Essentially, MJVD's proposal amounts to a tour organizer business rather than that of a carrier of passengers. However, under Section 1035 of the Public Utilities Code, she would be presumed to be a passenger stage corporation by her act of offering transportation on an individual-fare basis by bus between fixed termini and over a regular route.

In Pacifico Creative Service, Inc.'s (Pacifico) Application No. 58739 for a certificate of public convenience and necessity to operate various passenger sightseeing tours and Case No. 10732, J. Mark Lavelle (Dolphin Tours) versus Pacifico, combined for hearing, the question was raised concerning our jurisdiction over providers of tour services who charter both the necessary equipment and the driver from an independent bus company on a per hour or per diem basis. Certain parties to the above-referenced proceedings have contended that such tour service providers are more "transportation brokers" and do not operate as passenger stage corporations subject to the Commission's certification requirements. MJVD's proposed service is similar to the activity in question in Application No. 58739 and Case No. 10732. In Decision No. 92455 dated December 2, 1980, on those matters, we stated:

"We conclude that Pacifico, not the various charter-party carriers, owns, operates, controls, and manages <sup>23/</sup> a 'system for the transportation of people' within the meaning of Article XII, Section 3, even though it owns no equipment and leases none, and we further conclude that under Section 226, Pacifico 'controls' and 'manages' the passenger stage routes previously enumerated.<sup>24/</sup>  
..."

"<sup>23/</sup> While Pacifico meets all four requirements, it should be remembered that Article XII, Section 3 reads 'own, operate, control or manage.'

"<sup>24/</sup> To avoid redundancy we will not mention at each point in the discussion that the prepackaged tours sold in Japan are not the subject of this analysis and that we are concerned only with the optional tours." (Mimeo. p.44.)

Consequently, we will grant the requested certificate. MJVD, in accepting the certificate, agrees to abide by the requirements of GO 98-A in acquiring buses for her operations.

The findings and order which follow will make reference to tariff filings, insurance, and certain other requirements to be followed by MJVD.

A public hearing is not necessary. In the absence of protest and given MJVD's readiness to offer the proposed service, this order should be effective immediately.

#### Findings of Fact

1. MJVD seeks to establish and operate a common carrier passenger stage service for 24 sightseeing tours of the Palm Springs area.

2. MJVD possesses the ability, experience, and financial resources to perform the proposed service.

3. MJVD does not propose to use equipment of her own, or equipment leased and operated as her own. The Commission has authorized other passenger stage corporations to operate by using charter-party carriers' equipment in lieu of owned or leased equipment.

4. MJVD is required to abide by the requirements of CO 98-A, particularly Part 12.00, in acquiring buses for her operation.

5. MJVD has demonstrated that public convenience and necessity require certification of the services sought.

6. The proposed operations constitute passenger stage operations between fixed termini and over a regular route even though MJVD does not own nor does she propose to own any motor vehicles to be used in the operation of these tours.

7. The proposed individual fares are justified. Once published, fares may not be increased without the necessary showing and finding required by Section 454 of the Public Utilities Code.

8. A public hearing is not necessary.

9. It can be seen with certainty that there is no possibility that the activity in question may have a significant effect on the environment.

#### Conclusions of Law

1. The application should be granted.

2. Since there are no protests and since the public will benefit from immediate institution of the service, the following order should be effective the date of signature.

Mary Jeanne VanDeventer, dba Rancho Las Palmas Caravans or Caravan Tours, is placed on notice that operative rights, as such, do not constitute a class of property which may be capitalized or used as an element of value in rate fixing for any amount of money in excess of that originally paid to the State as the consideration for the grant of such rights. Aside from their purely permissive aspect,



such rights extend to the holder a full or partial monopoly of a class of business. This monopoly feature may be modified or canceled at any time by the State, which is not in any respect limited as to the number of rights which may be given.

O R D E R

IT IS ORDERED that:





1. A certificate of public convenience and necessity is granted to Mary Jeanne VanDeventer, dba Rancho Las Palmas Caravans or Caravan Tours, authorizing her to operate as a passenger stage corporation, as defined in Section 226 of the Public Utilities Code, between the points and over the route described in Appendix A hereof.
2. In providing service pursuant to the authority granted by this order, applicant shall comply with the following service regulations. Failure to do so may result in a cancellation of the authority.
  - (a) Within thirty days after the effective date of this order, applicant shall file a written acceptance of the certificate granted. Applicant is placed on notice that if she accepts the certificate she will be required, among other things, to comply with the safety rules administered by the California Highway Patrol, the rules and other regulations of the Commission's General Order No. 98-Series, and the insurance requirements of the Commission's General Order No. 101-Series.
  - (b) Within one hundred twenty days after the effective date of this order, applicant shall establish the authorized service and file tariffs and timetables, in triplicate, in the Commission's office.

- (c) The tariff and timetable filings shall be made effective not earlier than ten days after the effective date of this order on not less than ten days' notice to the Commission and the public, and the effective date of the tariff and timetable filings shall be concurrent with the establishment of the authorized service.
- (d) The tariff and timetable filings made pursuant to this order shall comply with the regulations governing the construction and filing of tariffs and timetables set forth in the Commission's General Orders Nos. 79-Series and 98-Series.
- (e) Applicant shall maintain her accounting records on a calendar year basis in conformance with the applicable Uniform System of Accounts or Chart of Accounts as prescribed or adopted by this Commission and shall file with the Commission, on or before March 31 of each year, an annual report of her operations in such form, content, and number of copies as the Commission, from time to time, shall prescribe.

(f) In the event applicant does not furnish the written agreement as set out in Ordering Paragraph 2(a) within the time specified, the application is denied.

The effective date of this order is the date hereof.

SECTION 1. GENERAL AUTHORIZATIONS, RESTRICTIONS, LIMITATIONS AND SPECIFICATIONS.

Mary Jeanne VanDeventer, an individual doing business as Rancho Las Palmas Caravans/Caravan Tours, by the certificate of public convenience and necessity granted by the decision noted in the margin, is authorized to transport passengers on sightseeing and pleasure tours originating and terminating at any of the pickup points listed in Section 2 of this Appendix A, on the one hand, and various points of interest on the tours as hereinafter described, on the other hand, over and along the most appropriate streets and highways and subject, however, to the authority of this Commission to change or modify said points or tour routes at any time and subject to the following provisions:

- (a) Motor vehicles may be turned at termini and intermediate points, in either direction at intersections of streets or by operating around a block contiguous to such intersections, in accordance with local traffic regulations.
- (b) When route descriptions are given in one direction, they apply to operation in either direction unless otherwise indicated.
- (c) All tours and passengers on tours shall originate and terminate at one or more of the authorized points in Section 2.
- (d) All service herein authorized shall be limited to the transportation of round-trip passengers only.
- (e) All tours shall be conducted on a continuous basis except for stops for sightseeing and meals.

- (f) Carrier shall not pick up or discharge passengers except at the specified service points of origin/destination as hereinafter set forth. This restriction shall not prevent stopovers for the purpose of permitting sightseeing passengers to visit various points of interest along the route.
- (g) No vehicle shall be operated over roads which are not public highways except when authorization is received from the owner or owners.
- (h) Tour stops may be eliminated at the discretion of the individual group. The carrier may make alterations in the tour itinerary within the limits of the authority granted.
- (i) The tours shall be operated for a minimum of six (6) persons.
- (j) Mary Jeanne VanDeventer, an individual, doing business as Rancho Las Palmas Caravans/Caravan Tours, shall furnish this Commission with written agreement that she will abide by Part 12.00 of this Commission's General Order No. 98-A Series in utilizing buses and drivers furnished by others.
