O P I N I O N

Applicant Joe Suter Construction Company, Incorporated, a California corporation, requests the issuance of a dump truck carrier permit. At the time of filing this application, applicant held no other operating authority from this Commission. Notice of the filing of the application appeared in the Commission's Daily Calendar of December 16, 1980. No protest to the application has been received.

Applicant's place of business is at 10312 Columbine, Truckee, California 95734. Applicant operates one end dump truck and proposes to haul dirt and rocks in the North Lake Tahoe Basin Area and between Truckee and said area and points in Nevada and Placer Counties. As of November 12, 1980, applicant's balance sheet indicates a net worth of \$131,282 with \$62,208 in cash. The application is supported by Sha-Neva, Inc., a California corporation.

Findings of Fact

1. Applicant is a fit and proper entity to receive a permit as a dump truck carrier and possesses sufficient operating knowledge and financial ability to perform the proposed operation.

2. Applicant's equipment will not endanger the safety of the highways nor impair the condition or maintenance of them either directly or indirectly.

3. Applicant's proposed operation will not unnecessarily burden the public highways, is necessary to serve the public, and will not impair the ability of presently permitted dump truck carriers to provide adequate service at the lowest possible reasonable rates.

4. Applicant has been incorporated in the State of California for not less than ninety days immediately preceding the filing of this application.

5. It can be seen with certainty that there is no possibility that the activity in question may have a significant effect on the environment.

6. The following order complies with the Commission's Energy Efficiency Plan.

Conclusions of Law

1. Applicant should be issued a dump truck carrier permit authorizing operations within and between all points in El Dorado, Nevada and Placer Counties.


2. The effective date of the order should be the date of issuance to be consistent with the issuance of permits to other classes of carriers.


O R D E R


