Application of Willig Freight Lines under Shortened Procedure Tariff Docket for authority to amend Item 6050, Paper of Willig Freight Lines Local Freight Tariff No. 5, Cal. P.U.C. No. 5. -AND-For authority to depart from the terms of Sections 452, 454, 460, and 491 of the Public Utilities Code when accomplishing proposed publication.

OPINION AND ORDER

By this application, James C. Olsson (Olsson), Consultant, for and on behalf of Willig Freight Lines (Willig) seeks authority to add gummed paper, other than cloth-lined, to Item 6050 of Willig's Local Tariff No. 5, Cal. P.U.C. No. 5 (Tariff 5).

Olsson states that Application 59897 sought authority to add certain commodities to Item 6050, PAPER, and that item is based on, and is the same as, Item 865 of Transition Tariff 2. Olsson further states that Application 59897 was in part submitted due to the expansion of shippers' product line, causing the need for an additional commodity to be included in the item. For the same reason Willig now finds that the requested product needs to be included in the same item.

According to Olsson, the amendment to include the additional commodity will benefit both the shipper and Willig, provide increased productivity for the carrier, lower overall cost to the shipper and increase energy efficiency for Willig.

Olsson declares that the proposal herein will not increase Willig's California intrastate gross revenue by as much as one percent.

The application was listed on the Commission's Daily Calendar of February 19, 1981. No objection to the granting of the application has been received. A public hearing is not necessary. Findings of Fact

1. Willig was authorized to add Item 6050 to its Tariff No. 5 by Decision 92396.

2. Addition of the requested commodity to Item 6050 will benefit both shipper and carrier.

3. The following order complies with the guidelines in the Commission's Energy Efficiency Plan.

4. A public hearing is not necessary.

Conclusion of Law

The Commission concludes that the application should be granted as set forth in the ensuing order.

IT IS ORDERED that:

1. Willig Freight Lines is authorized to add gummed paper, other than cloth-lined, in its Local Tariff No. 5, Cal. P.U.C. No. 5, as specifically proposed in the application.

2. Tariff publications authorized to be made as a result of the order herein shall be filed not earlier than the effective date of this order and may be made effective not earlier than five days after the effective date of this order on not less than five days' notice to the Commission and to the public.

3. The authority granted herein shall expire unless exercised within ninety days after the effective date of this order.

The effective date of this order shall be thirty days after the date hereof.
