ORDER EXTENDING SUSPENSION

The Pacific Telephone and Telegraph Company filed on January 30, 1981, tariff schedules which provide for the application of an access charge to private line services terminating in a telephone exchange. This tariff was filed pursuant to this Commission's Decision 90861 dated September 25, 1979. The Commission's order in Case 10948 filed February 18, 1981, suspended these tariffs until May 31, 1981. It is necessary to extend the suspension of these tariffs; therefore,

IT IS ORDERED that the operation of each of the tariff sheets set forth in Advice Letter 13822 of The Pacific Telephone and Telegraph Company is extended for a further period of six months, as provided by statute, to November 30, 1981, unless otherwise ordered hereafter.
