Application of Movin On Messenger Service, Inc., to publish on its own behalf tariff provisions resulting in increases due to changes in wording of various Items of our Cal. P.U.C. No. 2.

Shortened Procedure Tariff Docket Application 60548 (Filed May 13, 1981)

<u>O P I N I O N</u>

By this application Movin On Messenger Service, Inc. (Movin On) seeks to publish changes in its Local Messenger Tariff No. 1, Cal. P.U.C. No. 2, which will result in increases.

Movin On alleges that the changes are necessary to offset increased costs being experienced when transporting shipments weighing between 150 and 1,000 pounds. The application of the change could result in decreases depending upon the weight of the shipment and the distance traveled. Any decreases occurring would not be below Transition Tariff 2 levels.

Movin On states that the sought changes would not result in increases exceeding it gross annual revenue by as much as one percent.

Further, Movin On states "that they believe it can be seen with reasonable certainty that the granting of this application will not result in a significant effect on the environment and

for that reason, no environmental data statement is required. ...the granting of this application does not involve actions which significantly effect [sic] energy efficiency."

The application was listed on the Commission's Daily Calendar of May 15, 1981. No objections to the granting of the application have been received.

Findings of Fact

1. Movin On is a highway common carrier under Section 1063.5 of the Public Utilities Code.

2. Movin On has been experiencing increased expenditures because of additional time necessary for handling shipments weighing between 150 and 1,000 pounds.

3. The proposed tariff changes will return to Movin On the costs of providing the services.

4. The following order complies with guidelines in the Commission's Energy Efficiency Plan.

5. A public hearing is not necessary.

Conclusions of Law

 The rate increases resulting from the proposed changes are justified. 2. The tariff changes will result in rates and charges which are just and reasonable and the application should be granted as set forth in the ensuing order.

ORDER

IT IS ORDERED that:

1. Movin On Messenger Service, Inc. is authorized to amend its Local Messenger Tariff No. 1, Cal. P.U.C. No. 2 as specifically proposed in the application.

2. Tariff publications authorized to be made as a result of this order shall be filed not earlier than the effective date of this order and may be made effective not earlier than five days after the effective date of this order on not less than five days' notice to the Commission and to the public. 3. The authority granted shall expire unless exercised within 90 days after the effective date of this order.

This order becomes effective 30 days from today. Dated ______, at San Francisco, California.
