In the Matter of the Application of PACIFICO CREATIVE SERVICE, INC., a Hawaii corporation, for a certificate of public convenience and necessity for passenger sightseeing service in Alameda, Contra Costa, Los Angeles, Marin, Fresno, Mariposa, Merced, Monterey, Crange, Sacramento, San Diego, San Francisco, San Joaquin, San Mateo, Santa Clara, Santa Cruz, Solano, Sonoma, Stanislaus, Tuolumne, and Yolo Counties.

#### ORDER MODIFYING INTERIM DECISION

On June 2, 1981 we issued an interim decision (Decision (D.) 93161) granting temporary certificates to Pacifico Creative Service, Inc. (Pacifico) for the operation of certain sightseeing routes with tours conducted with Japanese-language narration.

On June 4, 1981 Pacifico filed a "petition to correct inadvertent errors", which we will treat under our Rules as a Petition for Modification. In a letter dated June 10, which was served on all parties, Pacifico's attorney invites our attention to certain additional problems with the certificate.

The administrative law judge wrote to the parties of record requesting any comments on the petition within ten days from the date of his letter (June 8, 1981). No comments were received.

Based upon a review of the petition, we make the findings of fact which follow.

# Findings of Fact

1. Conclusion of Law 2 of D.93161 contains an incorrect date and should read "October 31. 1981."

- 2. Footnote 2 cites Public Utilities (PU) Code § 703 but the citation should be § 704.
- 3. The certificate incorrectly shows Pacifico as a California corporation rather than as a Hawaii corporation. It also fails to designate Los Angeles, rather than San Francisco, as the starting point for some of the tours.
- 4. Exhibit 101 in the complaint phase of this proceeding (Case 10732) shows Pacifico's San Francisco Night tour as operating sufficiently to be considered a de facto route for purposes of our temporary certificate. The certificate should be amended to include this tour.

## Conclusion of Law

D.93161 should be modified to correct the errors and omissions listed in the preceding findings. The effective date of this decision should be the date it is signed so that Pacifico will be operating under a correct certificate.

#### IT IS ORDERED that:

- 1. The date in Conclusion of Law 2 of D.93161 is corrected to read "October 31, 1981."
- 2. The PU Code citation in footnote 2 is corrected to read "704".
- 3. Appendix'A of D.93161 is amended by replacing Original Pages 1 and 3 with First Revised Pages 1 and 3 (attached).

#### PACIFICO CREATIVE SERVICE, INC. (PSC-1154)

SECTION 1. GENERAL AUTHORIZATIONS, RESTRICTIONS, LIMITATIONS, AND SPECIFICATIONS.

Pacifico Creative Service, Inc., a Hawaii corporation, by the certificate of public convenience and necessity to operate as a passenger stage corporation granted by the decision noted in the margin, is authorized to transport passengers for sightseeing and pleasure trips between the City and County of San Francisco, or the City of Los Angeles, on the one hand, and certain named points, on the other hand, over and along the routes described, subject, however, to the authority of this Commission to change or modify these routes at any time and subject to the following provisions:

- a. All service authorized shall be limited to the transportation of round-trip passengers only.
- b. Service may be provided on a scheduled basis as reflected in the timetable filed with the Commission.
- c. All of the tours and special attractions shall be conducted in the Japanese language only.
