ORDER AMENDING DECISION 93079

By Decision (D.) 93079 dated May 19, 1981, in Application (A.) 60221 the Commission granted JATS Enterprise, Inc. (JATS) a temporary certificate of public convenience and necessity authorizing operations as a passenger stage corporation for the transportation of passengers on sightseeing tours between various points of interest throughout the State.

By an amendment filed May 6, 1981, JATS had requested the inclusion of a San Francisco Night Tour (without dinner) and a Los Angeles City Tour. The amendment was not provided for at the time the temporary certificate was issued, and JATS has since informed the Commission that it wishes to withdraw the proposed San Francisco tour.

All of the reasons justifying the grant of the temporary certificate also justify the amendment of the certificate by including a proposed Los Angeles tour, which would commence at the Los Angeles hotel of the passengers and include visits to scenic streets and points of interest as well as El Cid for entertainment viewing. The proposed adult fares are \$40, which would include two drinks, and \$50, which would include dinner.

After consideration the Commission finds that public convenience and necessity require that JATS' temporary certificated authority be amended to include a Los Angeles night tour. Because of the seasonal nature of the sightseeing business, this order will be made effective on the date that it is signed.

IT IS ORDERED that:

1. Appendix C of D.93079 is amended by substituting First Revised Page 3, attached, for Original Page 3. • A.60221 ALJ/km

2. Within 60 days after the effective date of this order and on not less than 5 days' notice to the Commission and to the public, JATS Enterprise, Inc. shall amend its tariffs and timetables to reflect the authority granted in this decision.

*5 Los Angeles City Night Tour Commencing at passengers' Los Angeles hotel, thence over the most appropriate and scenic streets visiting and viewing points of interest in the City of Los Angeles, such as Griffith Observatory, El Cid, and return to Los Angeles hotel.
