## ORDER MODIFYING DECISION 92728

By this application Devine & Son Trucking Co. (Devine) had sought an in lieu certificate of public convenience and necessity extending its highway common carrier authority to include the transportation of general commodities between all points north of the southern boundaries of Santa Barbara, Kern, and Inyo Counties. The authority was sought under Public Utilities (PU) Code Section 1063.

Devine had also requested that the restrictions in its PU Code Section 1063 general commodities certificate be simplified to conform with a list of articles set forth in its application.

The Commission dismissed the application by Decision (D.) 92728 dated February 18, 1981, because Devine also holds a statewide general commodities certificate granted under the provisions of PU Code Section 1063.5. This latter certificate authorizes Devine to perform all the service it requested in its application, subject to any restrictions it may wish to self-impose through appropriate tariff filings. (See Conclusion of Law 5, D.89575 dated October 31, 1978, in Case 5432, Order Setting Hearing 957.) It is the Commission's established policy to prohibit carriers from holding duplicate operating authorities. No registered interstate operating rights are involved in the proceeding.

Devine states it has filed this petition for modification of D.92728 because the commodity restrictions contained in its PU Code Section 1063 general commodities authority are confusing and complicated. Devine believes that the Commission, in dismissing the application, did not give consideration to the operational problems and to the rate and tariff complications stemming from the commodity restrictions which exist in connection with its present PU Code Section 1063 authorities. It seeks by this petition merely to simplify the commodity restrictions applicable in connection with its PU Code Section 1063 general commodities authority, and to exclude (1) service to and from the town of Camino, El Dorado County, and (2) shipments having both origin and destination within a described Sacramento area.

Devine's present commodity restrictions prohibit transportation of the articles usually excluded from general commodities certificates. However, several additional items are excepted, such as iron or steel cans, cotton, commodities afforded temperature control service, asphalt, roofing materials, and wallboard. The exclusion of these additional articles from its PU Code Section 1063 authority, Devine alleges, causes undue rate and tariff complications.

Devine also requests, in its amended petition for modification filled May 22, 1981, that the town of Camino be excluded from its PU Code Section 1063 certificate authorizing the transportation of lumber and forest products. It serves only one shipper in that community, who will be better served under Devine's contract carrier authority.

There have been no protests filed in connection with Devine's petition for modification, as amended. PU Code Section 1063 authorities held by Devine can be modified only by Commission

decision. There appears to be no valid reason not to grant the authority sought. These changes, if granted, will serve the interests of tariff simplification and will provide greater flexibility in serving the shipper located in the town of Camino and those shippers located within the described Sacramento area. Findings of Fact

- 1. Devine holds a certificate of public convenience and necessity issued under the provisions of PU Code Section 1063, authorizing the transportation of general commodities between various points in California. That certificate excludes the transportation of various commodities. It authorizes service to and from the town of Camino, El Dorado County, and between points situated in a Sacramento area described in Devine's application.
- 2. Devine also holds a certificate of public convenience and necessity issued under the provision of PU Code Section 1063, authorizing the transportation of lumber and forest products. That certificate authorizes service to and from the town of Camino, El Dorado County.
- 3. Devine requests in its petition for modification of D.92728 that the commodity restrictions applicable in connection with its PU Code Section 1063 general commodities authority be simplified as set forth in its petition for modification. It also requests exclusion of (1) service to and from the town of Camino and (2) shipments having both origin and destination within a described Sacramento area.
- 4. Devine requests in its amended petition for modification filled May 22, 1981, that the town of Camino be excluded from its PU Code Section 1063 certificate authorizing the transportation of lumber and forest products.

- 5. Devine's PU Code Section 1063 authorities may be modified only by Commission decision.
- 6. No protests have been received in connection with Devine's petition for modification, as amended.
- 7. The petition, as amended, appears reasonable and does not conflict with established Commission policy.
- 8. The following order has no reasonably foreseeable impact upon the energy efficiency of highway carriers.
- 9. It can be seen with certainty that there is no possibility that the activity in question may have a significant effect on the environment.
- 10. A public hearing is not necessary. Conclusion of Law

D.92728 and Devine's PU Code Section 1063 certificates should be modified in accordance with Devine's petition for modification, as amended.

Such conclusion, however, should not be construed as a policy determination with respect to future petitions to exempt certain transportation from a certificated authority.

There have been major changes in highway number designations as a result of the numerous highway construction programs accomplished in California over the last 20 years. It has been Commission policy to restate operating authorities when a large number of the highway designations contained in a given certificate are obsolete. Such being the case with these certificates, the operating authority will be restated to reflect the new highway designations currently in use. The restatement will not result in any geographical change in the scope of the rights. The order which follows will provide for the

revocation of the certificate granted by D.59847 dated March 29, 1960 in Application (A.) 41525 and amended numerous times, and the issuance of an "in lieu" certificate to the petitioner.

Only the amount paid to the State for operative rights may be used in rate fixing. The State may grant any number of rights and may cancel or modify the monopoly feature of these rights at any time.

## IT IS ORDERED that:

- 1. A certificate of public convenience and necessity as a highway common carrier is granted to Devine & Son Trucking Co., a California corporation, authorizing it to operate between the points and over the routes and subject to the exclusions set forth in Appendix A of this decision.
- 2. The certificate of public convenience and necessity granted in paragraph 1 shall supersede that granted by D.59847 dated March 29, 1960 in A.41525, as amended. That certificate is revoked on the effective date of the tariff filings required by paragraph 3.
  - 3. The petitioner shall:
    - a. File a written acceptance of this certificate within 30 days after this order is effective.
    - b. Establish the authorized service and file tariffs within 60 days after this order is effective.
    - c. State in its tariffs when service will start; allow at least 10 days notice to the Commission; and make tariffs effective 10 or more days after this order is effective.
    - d. Comply with General Orders Series 80, 100, and 123, and the California Highway Patrol safety rules.
    - e. Maintain accounting records in conformity with the Uniform System of Accounts.

f. Comply with General Order Series 84 (collect-on-delivery shipments). If applicant elects not to transport collect-on-delivery shipments, it shall file the tariffs required by that General Order.

This order becomes effective 30 days from today.
