BEFORE THE PUBLIC UTILITIES COMMISSION OF THE STATE OF CALIFORNIA

In the Matter of the Application ) of JOHN E. SCHULZ, doing business as FREEDOM FREIGHTWAYS, for a certificate of public convenience and necessity to operate as a highway common carrier for the transportation of general commodities, with certain exceptions, in intrastate commerce between points in California.

Application 60483 (Filed April 27, 1981)

### OPINION

John E. Schulz, doing business as Freedom Freightways, requests authority pursuant to Public Utilities (PU) Code Sections 1063 et seq. to operate as a highway common carrier for the transportation of general commodities with certain exceptions between all major points within the State of California.

Applicant's terminal facilities are located in the City of Glendale. In addition to his own motor vehicle equipment consisting of a 1979 International truck, applicant proposes to lease motor vehicles. Subhaulers will be used to augment applicant's own and leased equipment.

The proposed service would be daily Monday through Friday and Saturday upon request. Sundays and holidays are excepted. As of April 12, 1981 applicant indicated a net worth of \$11,683.

As justification for the authority sought, applicant alleges that during the past 15 years he has been engaged as **an owner-operator**

in interstate commerce transporting commodities exempt from regulation under Section 10526 of the Interstate Commerce Act, and within territories exempt from regulation under Section 10523 of the Interstate Commerce Act; that he has received, and continues to receive from the same shippers for whom he transports the aforementioned interstate movements, numerous requests for the transportation of general commodities, involving movements in intrastate commerce within the State of California, including those areas he presently serves as an exempt interstate carrier; and that granting of the requested authority will enable him to expand his intrastate operations to meet the continuing and anticipated needs of his shippers.

Notice of the filing of the application appeared in the Commission's Daily Calendar of April 29, 1981, and a copy of the application was served on the California Trucking Association. No protest has been received.

#### Findings of Fact

1. Applicant is presently conducting operations in interstate commerce transporting commodities and serving within areas that are exempt from regulation by the Interstate Commerce Act.

2. Applicant has received numerous requests for the transportation of general commodities, involving movements in intrastate commerce within the the State of California from the same shippers for whom he transports interstate shipments.

3. Applicant possesses the necessary experience, facilities, equipment, and financial ability to provide service as a certificated carrier.

4. Notice of the application appeared in the Commission's Daily Calendar of April 29, 1981, and a copy of the application was served upon the California Trucking Association. No protest has been received. 5. Public convenience and necessity require applicant's service as a highway common carrier for the transportation of commodities moving in intrastate commerce between points within the proposed area. A public hearing is not necessary.

6. It can be seen with certainty that there is no possibility that the activity in question may have a significant effect on the environment.

7. The following order complies with the Commission's Energy Efficiency Plan.

#### Conclusion of Law

The application should be granted.

Only the amount paid to the State for operative rights may be used in rate fixing. The State may grant any number of rights and may cancel or modify the monopoly feature of these rights at any time.

#### QRDER

IT IS ORDERED that:

1. A certificate of public convenience and necessity is granted to applicant John E. Schulz authorizing him to operate as a highway common carrier, as defined in PU Code Section 213, between the points and over the routes listed in Appendix A.

- 2. Applicant shall:
  - a. File a written acceptance of this certificate within 30 days after this order is effective.
  - b. Establish the authorized service and file tariffs within 120 days after this order is effective.

- c. State in his tariffs when service will start; allow at least 10 days' notice to the Commission; and make tariffs effective 10 or more days after this order is effective.
- Comply with General Orders Series 80, 100, and 104, and the California Highway Patrol safety rules.
- e. Maintain accounting records in conformity with the Uniform System of Accounts.
- f. Comply with General Order Series 84 (collect-on-delivery shipments). If applicant elects not to transport collecton-delivery shipments, he shall file the tariffs required by that General Order.

This order becomes effective 30 days from today.

- 4. Interstate Highway 10 between Los Angeles and Indio.
- 5. Interstate Highway 80 between San Francisco and Truckee.
- Interstate Highway 580 between Oakland and its intersection with Interstate Highway 5 near Westley.

Except that under the authority granted, carrier shall not transport any shipments of:

- 1. Used household goods and personal effects, office, store, and institution furniture and fixtures.
- 2. Automobiles, trucks, and buses, new and used.
- 3. Ordinary livestock.
- Liquids, compressed gases, commodities in semiplastic form, and commodities in suspension in liquids in bulk in any tank truck or tank trailer.
- 5. Mining, building, **paving**, and construction materials, except cement or liquids, in bulk in dump truck equipment.
- 6. Commodities when transported in motor vehicles equipped for mechanical mixing in transit.
- 7. Portland or similar cements, either alone or in combination with lime or powdered limestone, in bulk or in packages, when loaded substantially to capacity.
- 8. Articles of extraordinary value.
- 9. Trailer coaches and campers, including integral parts and contents when contents are within the trailer coach or camper.

- 10. Commodities requiring the use of special refrigeration or temperature control in specially designed and constructed refrigerator equipment.
- 11. Explosives subject to U.S. Department of Transportation Regulations governing the transportation of hazardous materials.
- 12. Fresh fruits, nuts, vegetables, logs, and unprocessed agricultural commodities.
- 13. Transportation of any commodity, the transportation or handling of which, because of width, length, height, weight, shape,or size, requires special authority from a governmental agency regulating the use of highways, roads or streets in any motor vehicle or combination of vehicles.
- 14. Transportation of liquid or semi-solid waste, or any other bulk liquid commodity in any vacuum type tank truck or trailer.

#### LOS ANGELES BASIN TERRITORY
